### ORDER:

During the Budget Speech, on 15.03.2018, among others, the following announcements were made on the floor of the Assembly:-

- i. வேளாண் இயந்திரமயமாக்கல் மற்றும் சந்தைகளை மேம்படுத்தி ஒருங்கிணைத்தல் ஆகியவை வேளாண் மேம்பாட்டிற்கு முக்கியப் பங்காற்றி வருகின்றன. 2014-2015 ஆம் ஆண்டு முதல் பண்ணை இயந்திரமயமாக்கலை ஊக்கப்படுத்த வேளாண் இயந்திரங்களை வாடகைக்கு வழங்கும் 1,106 மையங்களை அரசு ஏற்படுத்தியுள்ளது. 2018-2019 ஆம் ஆண்டில் மேலும் 500 மையங்கள் அரசால் ஏற்படுத்தப்படும். வேளாண் இயந்திரமயமாக்கலை ஊக்குவிக்க 2017-2018 ஆம் ஆண்டில் 71 கோடி ரூபாய் ஒதுக்கீடு செய்யப்பட்டது. 2018-2019 ஆம் ஆண்டில் 150 கோடி ரூபாய் இதற்கென ஒதுக்கீடு செய்யப்பட்டுள்ளது.

- ii. தொகுப்பு (Clusters) அடிப்படையில் 25 மாவட்டங்களில் உள்ள 10 இலட்சம் ஹெக்டேர் மானாவாரி நிலங்களை மேம்படுத்த 2016-2017 ஆம் ஆண்டில் தொடங்கப்பட்ட நீடித்த நிலையான மானாவாரி வேளாண்மைக்கான சிறப்புத் திட்டத்தில் (Mission on Sustainable Dry Land Agriculture), 2017-2018 ஆம் ஆண்டில் 175.16 கோடி ரூபாய் செலவில் 400 மானாவாரித் தொகுப்புகள் உருவாக்கப்பட்டுள்ளன. இந்தத் தொகுப்புகளில் உற்பத்தியைத் தொடர்ந்து மேம்படுத்துவதுடன், மேலும் 400 புதிய மானாவாரித் தொகுப்புகளை ஏற்படுத்த 2018-2019 ஆம் ஆண்டில் 321.16 கோடி ரூபாய் செலவிடப்படும்.

2. During the 16<sup>th</sup> State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 02.04.2018 among others, the project proposals of the Chief Engineer (Agricultural Engineering) were approved for the year 2018-19, for an amount of Rs.54.00 crore.

3. In the letter 2<sup>nd</sup> read above, the Government of India have made an allocation of Rs.165.20 crore as its share under NADP for the year 2018-19 and released a sum of Rs.82.60 lakh as first installment. By adding the corresponding State share of Rs.110.13 crore, in the funding pattern of 60 : 40, between the Central Government and the State Government, the total allocation works out to Rs.275.33 Crore under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for the year 2018-19.

4. In the letter 3<sup>rd</sup> read above, the Executive Director, Tamil Nadu Watershed Development Agency has prioritized the projects and have downsized the allocation for an amount of Rs.3800 lakh to the Chief Engineer (Agricultural Engineering) as follows:

5. In the letters 4<sup>th</sup> to 8<sup>th</sup> read above, the Chief Engineer (Agricultural Engineering), after downsizing the cost, has sent the prioritized project proposals to the tune of Rs.3800 lakh under National Agriculture Development Programme 2018-19 to the Government for issue of sanction orders.

6. While moving the Demand No.5 on 12.06.2018, the Hon'ble Minister for Agriculture has made the following announcement on the floor of Assembly:-

“வாழை, அன்னாசி, மாம்பழம், கொப்பரைத் தேங்காய், மிளகாய் வற்றல், தக்காளி, முருங்கை இலை, கறிவேப்பிலை, மருத்துவ மூலிகைகள், பூண்டு, இலவங்கம் போன்ற வேளாண் விளைபொருட்களை தூய்மையான முறையிலும், சுகாதாரமான முறையிலும், விரைவாக உலர்த்தி, மதிப்புக்கூட்டி, விவசாயிகள் அதிக இலாபம் ஈட்டுவதற்காக, நடப்பு ஆண்டில் 50 சதவீத மானியத்தில், 400 சதுர அடி முதல் 1000 சதுர அடி வரை பரப்பளவுள்ள சூரிய கூடார உலர்த்திகள் 2 கோடி ரூபாய் மானியத்தில் விவசாயிகள் மற்றும் விவசாய குழுக்களுக்கு அமைத்து தரப்படும்”.

7. With a view to implement the announcements made during the Budget Speech and the announcement made by the Hon'ble Minister (Agriculture) while moving Demand No.5 on 12.06.2018, the Government examined the proposal of the Chief Engineer (Agricultural Engineering) and accord administrative sanction for a sum of Rs.3800.00 lakh and financial sanction for a sum of Rs.1900.00 lakh (Rupees Nineteen Crore only) being the 1<sup>st</sup> installment release for implementation of the project Nos.16.23, 16.24, 16.26 and 16.28 of the Chief Engineer (Agricultural Engineering) under National Agriculture Development Programme/ Rashtriya Krishi Vikas Yojana 2018-19, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and State Governments.

8. The expenditure sanctioned in para (7) above shall be debited to the Head of Account and Component wise details as mentioned in the annexure to this order.

9. Necessary additional funds of Rs.6.50 lakh will be provided in Revised Estimate / Final Modified Appropriation 2018-19 under the relevant head of account by the way of Re-appropriation from the head of account “2402-00-102-UU 1101” and “4402-00-102-UD 1600”. Pending provision of such funds, the Chief Engineer (Agricultural Engineering) is permitted to draw and disburse the amount sanctioned in para.7 above. He is also requested to include this item of expenditure, while sending the proposal for Revised Estimate / Final Modified Appropriation 2018-19 to the Government in Finance (Agri/BG.I) Department at the appropriate time without fail.

10. The Chief Engineer (Agricultural Engineering) will be Estimating, Reconciling and Controlling authority to the above new sub heads of account. The PAO / Treasury Officer's are requested to open the above new sub heads of account in their account.

11. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Chief Engineer (Agricultural Engineering) should take due care to ensure that there is no duplication of subsidy.

12. The Chief Engineer (Agricultural Engineering) should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.

13. The Chief Engineer (Agricultural Engineering) shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.

14. The Chief Engineer (Agricultural Engineering) is directed to follow the RKVY-RAFTAAR operational guidelines while implementing the schemes.

15. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.

16. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
