### ORDER:

In the Government Order first read above, orders have been issued sanctioning a sum of Rs.1,24,36,148/- payable to the Insurance Companies towards settlement of State share of premium subsidy as upfront subsidy for Kharif, 2017 season after adjusting the earlier excess release (Rs.63,50,000/- to Agriculture Insurance Company of India Limited, Rs.47,76,148/- to ICICI Lombard General Insurance Company Limited, Chennai and Rs.13,10,000/- to New India Assurance Company Limited).

2. In the Government Order second read above, orders have been issued sanctioning a sum of Rs.11,63,55,190/- payable to the Insurance Companies towards settlement of State share of premium subsidy for Kharif, 2017 season for Agriculture crops (Rs.8,44,17,698/- to Agriculture Insurance Company of India

Limited, Rs.94,13,688/- to ICICI Lombard General Insurance Company Limited, Chennai and Rs.2,25,23,804/- to New India Assurance Company Limited).

3. In the Government Order third read above, orders have been issued sanctioning a sum of Rs.19,53,804/- towards the settlement of State Government share of premium subsidy payable to Agriculture Insurance Company of India Limited for Paddy II (Samba/Thaladi/Pishanam) during Rabi, 2016 – 2017 season i.e. Rs.1,05,896/- towards the settlement of full and final claims to two farmers of Ramanathapuram district and Rs.18,47,908/- towards the settlement of claims to 437 farmers of Trichy, Ariyalur, Ramanathapuram and Tiruvarur districts.

4. In the Government Order fourth read above, orders have been issued sanctioning a sum of Rs.2,12,13,624/- payable to Agriculture Insurance Company of India Limited towards the settlement of State Government share of premium subsidy for Kharif, 2017 season for Agriculture crops under Pradhan Mantri Fasal Bima Yojana.

5. In the Government Order fifth read above, orders have been issued sanctioning a sum of Rs.18,68,703/- towards the State Government share of premium subsidy that had arisen due to wrong data entry made by the District Central Cooperative Bank, Ramanathapuram and District Central Cooperative Bank, Thanjavur covering 548 farmers of Ramanathapuram and Tiruvarur districts for Paddy II season, Rabi 2016-2017 under Pradhan Mantri Fasal Bima Yojana.

6. In his letter sixth read above, the Director of Agriculture has stated that Agriculture Insurance Company of India Limited, Chennai has now requested to release the State Government share of Premium subsidy for a sum of Rs.16,714/- additionally, as there is further revision of Area Insured under Paddy – II during Rabi, 2016-17 season due to errors committed by their intermediary of Agriculture Insurance Company of India Limited viz. M/s.Alegion Insurance Broking Limited in booking the extent of insurance coverage. Further, the Agriculture Insurance Company of India Limited has also requested to sanction a balance sum of Rs.5,40,891/- towards State Government share of premium subsidy for Kharif, 2017 season based on their Final Business Statistics submitted by them. However on scrutiny, it is observed that Agriculture Insurance Company of India Limited is eligible for Rs.5,29,264/- only as detailed below:-

The Director of Agriculture has, therefore, requested the Government to accord financial sanction for a sum of Rs.5,45,978/- towards settlement of pending State Government share of premium subsidy for Paddy II (Samba / Thaladi / Pishanam) of Rabi 2016-2017 and Kharif, 2017 season for Agriculture crops [Rs.16,714/- (Rabi, 2016-2017 season) + Rs.5,29,264/- (Kharif, 2017 season)] payable to Agriculture Insurance Company of India Limited, Chennai.

8. The Government, after careful examination of the proposal of the Director of Agriculture, hereby accord sanction for a sum of Rs.5,45,978/- (Rupees Five Lakh Forty Five Thousand Nine Hundred and Seventy Eight only) payable to Agriculture Insurance Company of India Limited towards settlement of pending State Government share of premium subsidy for Paddy II (Samba / Thaladi / Pishanam) of Rabi 2016-2017 and Kharif, 2017 season for Agriculture crops [Rs.16,714/- (Rabi, 2016-17 season) + Rs.5,29,264 (Kharif, 2017 season)].
