ORDER:

In Tamil Nadu, 10 Bio Control Labs and 2 Integrated Pest Management Centers are functioning at Trichy, Thanjavur, Namakkal, Erode, Coimbatore, Dharmapuri, Madurai, Tirunelveli, Salem, Villupuram, Madurai (Vinayagapuram) and Kancheepuram.

- 2. In the Government Order first read above, sanction was accorded for a sum of Rs.145.79 lakh for the implementation and continuance of scheme for production of Bio Control Agents viz., Pseudomonas Fluorescens (17,000 kg), Trichoderma Viridi (1,67,000 kg). Nuclear Polyhedrosis Virus, Trichogramma Chilonis and Green Muscardine Fungus, in 10 Bio-Control Labs and 2 Integrated Pest Management Centers for the year 2015-2016.
- 3. In the letters second read above, the Commissioner of Agriculture has requested the Government to sanction a sum of Rs.301.81 lakh for implementation and continuance of the scheme viz., "Plant Protection-Production of the Bio- Control agents in 10 Bio-control Labs and 2 Integrated Pest Management Centres" for the year 2016-17 as detailed below:-
