ORDER:

During the 16<sup>th</sup> State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 02.04.2018, among others, the project proposals of the Tamil Nadu Veterinary and Animal Sciences University were approved for the year 2018-19, for an amount of Rs.682.14 lakh.

2. In the letter 2<sup>nd</sup> read above, the Government of India have made an allocation of Rs.165.20 crore as its share under National Agriculture Development Programme for the year 2018-19 and released a sum of Rs.82.60 crore as first installment. By adding the corresponding State share of Rs.110.13 crore, in the funding pattern of 60:40, between the Central Government and the State Government, the total allocation works out to Rs.275.33 Crore under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana for the year 2018-19.

3. In the letter 3<sup>rd</sup> read above, the Executive Director, Tamil Nadu Watershed Development Agency has prioritized the projects for an amount of Rs.301.10 lakh to the Tamil Nadu Veterinary and Animal Sciences University as follows:

4. In the letter 4<sup>th</sup> read above, the Registrar, Tamil Nadu Veterinary and Animal Sciences University, has sent the prioritized project proposals to the tune of Rs.301.10 lakh under National Agriculture Development Programme 2018-19 and the details of Head of Account to the Government for issue of sanction of orders.

5. Subsequently, the Hon'ble Minister for Animal Husbandry, interalia, has made the following announcements on the floor of Assembly on 01.06.2018:-

2. தமிழ்நாடு கால்நடை மருத்துவ அறிவியல் பல்கலைக் கழகத்தால் உருவாக்கப்பட்ட, குறைந்த உள்ளீட்டுத் தொழில்நுட்ப மரபணுக் கோழிகளான நந்தனம் கோழி-4 மற்றும் நாட்டுக் கோழி (அசீல்) ஆகியவற்றை ஊக்குவிக்கும் வகையில், சென்னை மாதவரத்தில் ரூ.1.51 கோடி ஒதுக்கீட்டில் ஊரக கோழி உள்ளீடு மற்றும் திறன் வளர்ப்பு மையம் அமைக்கப்படும். நல்ல இறைச்சி உற்பத்தி, மதிப்பு கூட்டுதல், உப பொருட்கள் உபயோகம் மற்றும் இறைச்சிக்கூட கழிவு மேலாண்மை ஆகியவை பற்றிய பயிற்சிகள் கிராமப்புற வேலைவாய்ப்பற்ற இளைஞர்கள் மற்றும் பெண்களுக்கு வழங்கப்படும்.

6. With a view to implement the announcements made by the Hon'ble Minister for Animal Husbandry, the Government examined the proposal of the Registrar, Tamil Nadu Veterinary and Animal Sciences University and accord administrative sanction for a sum of Rs.301.10 lakh (Rupees Three crore one lakh and ten thousand only) and financial sanction for a sum of Rs.150.55 lakh (Rupees One crore fifty lakh and fifty five thousand only) under National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana 2018-19 being the 1<sup>st</sup> installment release for implementation of the project Nos.16.76 and the merged project Nos.16.79 & 16.80 of Tamil Nadu Veterinary and Animal Sciences University subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and State Governments.

8. The Registrar, Tamil Nadu Veterinary and Animal Sciences University is the Estimating, Reconciling and Controlling authority for the above new head of account. The Pay and Accounts Officer / Treasury Officer concerned are directed to open the above new head of account in their books.

9. Necessary additional funds of Rs.1.65 lakh will be provided in Revised Estimate / Final Modified Appropriation 2018-19 to meet the expenditure sanctioned in para.6 above. Pending provision of such funds, the Director of Animal Husbandry and Veterinary services is authorized to draw and disburse the amount sanctioned in para.6 above to the Registrar, Tamil Nadu Veterinary and Animal Sciences University concerned for the implementation of the projects. He is also requested to include this expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2018-19 to Finance (AHD & F) Department at an appropriate time without fail.

10. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Registrar, Tamil Nadu Veterinary and Animal Sciences University should take due care to ensure that there is no duplication of subsidy.

11. The Registrar, Tamil Nadu Veterinary and Animal Sciences University should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.

12. The Registrar, Tamil Nadu Veterinary and Animal Sciences University shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.

13. The Registrar, Tamil Nadu Veterinary and Animal Sciences University is directed to follow the respective operational guidelines while implementing the schemes.

14. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.

15. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
