ORDER:-

- 6. The Government after careful examination, accept the proposal of the Director of Agriculture and accord financial sanction for an amount of Rs.1399.50 Lakh (Rupees Thirteen crores ninety nine lakhs and fifty thousand only) for implementation of the Seed Village Programme (SVP) and Certified Seed Production (CSP) under Sub-Mission on Seeds & Planting Materials (SMSP) of National Mission on Agricultural Extension & Technology (NMAET) for the year 2018-19, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and State Governments.

- 8. Necessary additional funds of Rs.160.01 lakh will be provided in Revised Estimate/ Final Modified Appropriation 2018-19 under the relevant head of accounts by the way of Re-appropriation from the head of account "2401 00 102 UC 09-03". Pending provision of such funds, the Director of Agriculture is permitted to authorise to draw and disburse the amount under relevant Head of Account. He is also requested to include this expenditure while sending the proposal for Revised Estimate/ Final Modified Appropriation 2018-19 to Government in Finance (Agri) Department at the appropriate time without fail.
- 9. The Government also ratify the action of Director of Agriculture in having issued 'Go ahead' orders for the implementation of the scheme during 2018-19 in anticipation of the Government of India approval due to commencement of sowing season.
- 10. The Director of Agriculture is directed to follow the terms and conditions stipulated by the Government of India letter 4th read above while implementing the scheme.
- 11. The Director of Agriculture is also requested to ensure that as per Government of India guidelines, the funds are utilized for the purpose it has been released (i.e. for General farmers/SC farmers/ST farmers) and no diversion of funds are allowed in any case. He is also directed to ensure that adequate funds are allocated for women farmers.
- 12. The Director of Agriculture is requested to submit the quarterly Physical and Financial Progress Report and Utilization Certificate in the prescribed proforma (GFR-19A) to Government and Government of India.
- 13. This order issues with the concurrence of Finance Department vide its U.O.No.35985/Agri/2018, dated 01.08.2018 and Additional Sanction Ledger No.872 (Eight Hundred and Seventy Two).
