ORDER:

In the G.O. first read above, orders were issued for fixation of sale price of various Micro Nutrient Chemicals and Mixtures during the period from 1.4.2014 to 31.3.2015.

- 2. Now, Director of Agriculture in his letter second read above, has forwarded the sale price fixation proposal for 14 Micro Nutrient Mixture fertilizers for 2015-2016 sent by the Assistant Director of Agriculture (Annavasal), Central Control Laboratory, Kudumianmalai for approval. While fixing the price the total cost of raw chemicals and polythene bags, Transport charges, labour charges, Spillage, driage and other losses, depreciation cost of machinery, building, sundries and establishment charges have been taken into consideration. The Director of Agriculture has, therefore, requested the Government to approve the sale price of 14 Micro Nutrient Mixtures suggested by him for the year 2015-2016.
- 3. The Government, after careful consideration, approve the sale price of 14 Mixture of Micro Nutrient Fertilizers for the year 2015-2016 as indicated in the Annexure to this order for the period from 1.4.2015 to 31.3.2016, subject to the condition that the cost of production and distribution including staff cost, if any should be recovered in full, by sale proceeds.

- 4. The action of the Director of Agriculture in having permitted the Assistant Director of Agriculture, Annavasal Central Control Laboratory, Kudumiyanmalai to adopt the sale price with effect from 1.4.2015 in anticipation of orders of the Government is also ratified.
- 5. The receipts in respect of sale of Mixture of Micro Nutrient Fertilizers shall be credited under the following head of account:-
- "0401-00-Crop-Husbandry-105-Sale of manures and Fertilizers AD. Receipt from sale of Micro Nutrient Mixture for Ground nut (0502) (DPC 0401-00-105-AD-0003).
