ORDER:

In the Government Order first read above, orders were issued for the implementation of Micro Nutrient Mixture Scheme at a total cost of Rs. 5,22,96,000/- during the year 2015-2016.

2. In the letter second read above, the Commissioner of Agriculture has sent the proposal for the continuance of the scheme at a total cost of Rs.11,70,00,000/- during the year 2016-2017 for production of 2400 MT Micro Nutrient Mixture.

3. The Government after careful examination have decided to permit Commissioner of Agriculture to continue the Micro Nutrient Mixture Scheme for the year 2016-2017 and sanction a sum of Rs.11,39,28,000/- (Rupees Eleven Crore and thirty nine lakh and twenty eight thousand only) towards production of Micro Nutrient Mixture at a target of 2400 MT as detailed in Annexure subject to recover the expenditure in full through sale price.

4. The expenditure sanctioned in para 3 above shall be debited to the Head of Accounts as detailed in Annexure to this order.

5. Necessary additional funds of Rs.616.37 Lakh will be provided in Revised Estimate / Final Modified Appropriation 2016-17 under the relevant head of accounts. Pending provision of such funds the Director of Agriculture is permitted to draw and disburse the amount sanctioned in para 3 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate. The Director of Agriculture is requested to include this expenditure while sending the proposal for RE/FMA 2016-17 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2016-17 to Government in Finance (Agri/BG-I)Department at the appropriate time without fail.
