ORDER:

In the Government Order first read above, orders were issued for continuance of the Micro Nutrient Mixture Scheme at a total cost of Rs8,97,26,000/- during the year 2017-2018.

2. In the letter second read above, the Director of Agriculture has sent the proposal for the further continuance of the scheme with staff for production of 3780 MT Micro Nutrient Mixture at a total cost of Rs. 13,53,31,727/- during the year 2018-19.

3. The Government after careful examination, have decided to accept the proposal of Director of Agriculture and accordingly order further continuance of the Micro Nutrient Mixture Scheme with staff for the period from 01.04.2018 to 31.03.2019 and sanction a sum of Rs.9,68,87,000/-(Rupees Nine Crore sixty eight lakh eighty seven thousand only) towards production of Micro Nutrient Mixture at annual target of 3780 MT.
