ORDER:-

In the Government Order 3rd read above, orders were issued for implementation of 15 Pesticide Testing Laboratories at a total cost of Rs.5,72,97,000/- during the year 2017-2018.

In the Government order 4th read above, notification for Pesticide Testing Laboratory cum Coding Centre at Cuddalore, Erode and Theni, Notification of Agricultural Chemist / Deputy Director of Agriculture (Chemistry) as Coding Officer / Insecticides Analysts and Notification of Assistant Director of Agriculture (Insecticide Analyst / Assistant Agricultural Chemist) at Pesticide Testing Laboratories at Kancheepuram and Coimbatore as Insecticide Analyst along with Instructions were issued.

3. In the letter third read above, the Director of Agriculture has sent proposal for continuance of the 15 Pesticide Testing Laboratories at a cost of Rs.845.682 lakh during 2018-2019 as detailed below:-
