ORDER:

In the Government order first read above, approval was accorded for fixation of sale price of 14 Micro Nutrient Mixtures for the year 2017 - 2018 (from 1.4.2017 to 31.3.2018).

- 2. Now, the Director of Agriculture in his letter second read above, has stated that sale price fixation proposal for the Micro Nutrient Mixtures for 2018 2019 has been received from the Joint Director of Agriculture, Pudukottai. He has also stated that while fixing the price, the total cost of raw chemicals and polythene bags, Transport charges, labour charges, Spillage, driage and other losses, depreciation cost of machinery, building, sundries and establishment charges have been taken into consideration. He has therefore requested the Government to approve the sale price of 14 Micro Nutrient Mixtures for the year 2018-2019 and to permit him to adopt the sale price with effect from 1st April 2018.
- 3. The Government, after careful examination accept the proposal of the Director of Agriculture and approve the sale price of 14 Micro Nutrient Mixtures for the year 2018-2019 (from 1st April 2018 to 31st March 2019) as detailed below on the condition

that the cost of production and distribution including staff cost, if any, should be recovered fully by sale proceeds:-
