ORDER:

In the Government Order first read above, orders have been issued notifying the Crops, Districts, Firkas, Revenue Villages, Insurance Units and approved premium rates for Agricultural and Horticultural Crops for effective implementation of Pradhan Mantri Fasal Bima Yojana during Kharif, 2017 season.

- 2. In the Government Order second read above, orders have been issued according administrative approval for implementation of Pradhan Mantri Fasal Bima Yojana at a cost of Rs.522.70 crore in all the districts of Tamil Nadu except Chennai during 2017-2018 as per the administrative approval and Operational Guidelines of Pradhan Mantri Fasal Bima Yojana issued by the Government of India for agriculture and horticulture crops.
- 3. In the Government Order third read above, orders have been issued sanctioning an amount of Rs.150.72515 lakh towards the State share premium subsidy for Kharif 2017-18 for horticulture crops to the three Insurance Companies [Rs.15,00,000/- to Agriculture Insurance Company of India Limited, Rs.36,48,000/- to ICICI Lombard General Insurance Company Limited, Chennai and Rs.99,24,515/- to New India Assurance Company Limited] (upfront bill by Agriculture Insurance Company of India Limited and ICICI Lombard General Insurance Company Limited and provisional bill by New India Assurance Company Limited).

- 4. In the Government Order fourth—read above, orders have been issued according administrative approval for implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) during 2018-2019 in Tamil Nadu at a cost of Rs.631.60 crore in all the districts of Tamil Nadu (except Chennai).
- 5. In the Government Order fifth read above, orders have been issued sanctioning an amount of Rs.258.55562 lakh as second installment state share of premium subsidy for Kharif 2017 for horticulture crops to the three Insurance Companies (Agriculture Insurance Company of India Limited Rs.123.47 Lakh, ICICI Lombard General Insurance Company Limited Rs.134.91124 Lakh and the New India Assurance Company Limited Rs. 0.17438 Lakh).
- 6. The Director of Horticulture and Plantation Crops in his letter sixth read above among others, has stated that after final reconciliation, the Agriculture Insurance Company of India (AICIL) has now submitted the Kharif, 2017 subsidy claim bill for final release for an amount of Rs.4,26,414/- and furnished the details as follows:-

- 7. Based on the claim bill received from Agriculture Insurance Company of India Limited, the Director of Horticulture and Plantation Crops has requested the Government to sanction an amount of Rs.4,26,414/- as final release of State share premium subsidy for Kharif 2017-18 to Agriculture Insurance Company of India Limited.
- 8. The Government, after careful examination of the above proposal of the Director of Horticulture and Plantation Crops hereby accord sanction for a sum of Rs.4,26,414/- (Rupees Four Lakh Twenty Six Thousand Four Hundred and Fourteen only) towards final release of State share premium subsidy for Kharif 2017-18 to Agriculture Insurance Company of India Limited.

- 11. The Director of Horticulture and Plantation Crops is directed to take immediate steps to introduce computerization of the process of Crop Insurance for better transparency in the enrolment of farmers for Crop Insurance.
