ORDER:-

The Director of Horticulture and Plantation Crops has sent a proposal for Production and Distribution of Planting Material Dendrobium(Orchids) for cultivation to the Farmers at nominal rate and demonstrate the Orchids Cultivation in Tamil Nadu at a cost of Rs.50.00 lakh.

- 2. Orders were issued in G.O.first read above, sanctioning a sum of Rs.50.00 lakh for the Production and Distribution of Planting materials Dedrobium (Orchids) cultivation to farmers at a nominal rate and demonstrate the orchids cultivation in Tamil Nadu under Part-II Scheme for the year 2014-15.
- 3. In the letter second read above, the Director of Horticulture & Plantation Crops has now stated and requested that an amount of Rs.50.00 lakh was provided under Revenue Section of the relevant head of account "2401 00 119 BD 119" for production and distribution of Planting Material Dendrobium under Part-II Scheme for the year 2014-15, as the above said amount had been provided under revenue section of the relevant head of account it has been audited by the Treasury Officer, Kancheepuram and ultimately surrendered. He has therefore requested to re-allocate the sum of Rs.50.00 lakh under capital section of the relevant head of account which was sanctioned under Revenue Section of head of Account under Part-II Scheme for the year 2014-15 for implementation of the said scheme in Aathur State Horticulture Farm, Kancheepuram district during 2015-16.

- 4. The Government after careful examination, accept the above proposal and release a sum of Rs.50,00,000 (Rupees Fifty lakh only) for the Production and Distribution of Planting Material Dendrobium (Orchids) for Cultivation to the farmers at nominal rate and to demonstrate the orchids cultivation in Tamil Nadu for the year 2016-17, which was already sanctioned in G.O first read above.
- 5. The expenditure sanctioned in para-4 above shall be debited to the following new head of account opened under Demand No.05 HOD:05:-

4401-00-Capital Outlay on Crop Husbandry-119 Horticulture and Vegetable Crops-Scheme in the Twelfth Five Year Plan-11 State Plan JM Production and Distribution of Planting Material Dendrobium cultivation to the Farmers and Demonstrate the Orchids cultivation 16 Major works. (DPC 4401 00 119 JM 1600)

- 6. The Director of Horticulture and Plantation Crops is the estimating Reconciling and controlling authority for the above new head of account. The Public Account Officer/Treasury Officer's concerned are requested to open the above new head of account in their books.
- Necessary additional funds will be provided in RBE/Revised Estimates/Final Modified Appropriation 2016-17. Pending provision of such funds, the Director of Horticulture & Plantation Crops is permitted to draw and disburse the amount sanctioned in para 4 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Revised Budget Estimate/Supplementary Estimate 2016-2017. The Director of Horticulture & Plantation Crops is requested to include this expenditure while sending the Revised Budget Estimate/Revised Estimates/Final Appropriation 2016-17 and also to send necessary explanatory notes for including the above expenditure in the Revised Budget Estimate / Supplementary Estimates 2016-2017 to Government in Finance (Agri/BG-I) Department at the appropriate time without fail
- 8. The Director of Horticulture and Plantation Crops is also instructed to send a detailed report to Government indicating the utilization of the amount sanctioned in para-4 above.
- 9. This order issues with the concurrence of the Finance Department vide its U.O.No.23474/Agri/2016, dated: 22.04.2016 and Additional Sanction Ledger No.72 (Seventy Two).
