ORDER:

In the Government order first read above, orders were issued for distribution of Bio-Fertilizer to farmers in the name of "Amma Bio-Fertilizer".

In the circumstances explained by the Director of Agriculture in his detailed proposal sent to the Government in the letter second read above, the Director of Agriculture has proposed to distribute Bio-fertilizers in the name of "Amma Bio-fertilizers" during the financial year 2018-19 onwards, for which production of 3000 MT of Carrier based Bio-fertilizer and 6.0 lakh litres of Liquid Bio-Fertilizer during has been programmed 2018-19 as follows:-

Since, the packing specification with detailed description has to be finalized before the procurement of above items, the Director of Agriculture has sent the details of (1) Design for labels of HDPE bottles (2) Design for Printing Polythene Bags (outer cover) (3) Design for Cotton Boxes & Printed Polywoven HDPE Sacks to the Government and requested orders on the following:
 - i. approval for the design of specification of Packing materials and labels in the name of Amma Bio-fertilizers.
 - ii. to distribute Bio-fertilizers in the name of "Amma Bio-fertilizers" from 2018-19 onwards.
