### ORDER:

In the Government order first read above, sanction was accorded for a sum of Rs. 33.82 lakh for distribution of the Bio–Control Agents / Bio–pesticides and sale through Agricultural Extension Centres under the Plant Protection Scheme during 2015-16.

2. The Commissioner of Agriculture in his letters second read above has sent the proposal for implementation of Plant Protection Scheme during 2016-17 at a total cost of Rs.51.32 lakh for distribution of the Bio–Control Agents / Bio–pesticides and sale through Agricultural Extension Centres.

3. The Government after careful examination, accept the proposal of the Commissioner of Agriculture and sanction a sum of Rs.24.74 lakh (Rupees twenty four lakh and seventy four thousand only) to the Commissioner of Agriculture for distribution of the Bio–Control Agents / Bio–pesticides and sale through Agricultural Extension Centres under the Plant Protection Scheme during 2016-17 as indicated in Annexures I & II to this order.

4. The expenditure sanctioned above shall be debited to the following heads of account:-

"2401 – 00 - Crop Husbandry – 789 - Special Component Plan for Scheduled Castes – Schemes in the Twelfth Five Year Plan – II State Plan – JC Crop and Plant Protection

(DPC 2401-00-789 -JC-0008)"

5. The Government direct that the sale price of the Bio-pesticides should be fixed to recover the expenditures incurred on staff cost, the cost of procurement of Bio – Control Agents and distribution cost in full.

6. The receipts realized towards the scheme shall be credited under the following head of account:-

"0401-00 Crop Husbandry 107-Receipts from Plant Protection Services - AA -Plant Protection Services.






