In the Government order first read above, approval was accorded for fixation of sale price of 14 Micro Nutrient Mixtures for the year 2016 - 2017 (from 1.4.2016 to 31.3.2017).

- 2. Now, the Director of Agriculture in his letter second read above, has stated that sale price fixation proposal for the Micro Nutrient Mixtures for 2017 2018 has been received from the Joint Director of Agriculture, Pudukottai. He has also stated that while fixing the price, the total cost of raw chemicals and polythene bags, Transport charges, labour charges, Spillage, driage and other losses, depreciation cost of machinery, building, sundries and establishment charges have been taken into consideration. He has therefore requested the Government to approve the sale price of 14 Micro Nutrient Mixtures for the year 2017-2018 and to permit him to adopt the sale price fixation with effect from 1st April 2017.
- 3. The Government, after careful examination accept the proposal of the Director of Agriculture and approve the sale price of 14 Micro Nutrient Mixtures for the year 2017-2018 (from 1st April 2017 to 31st March 2018) as detailed below on the condition that the cost of production and distribution including staff cost, if any, should be recovered fully by sale proceeds:-
