### **Order:**

In the Government Order 1<sup>st</sup> read above, orders have been issued to permit the Assistant Executive Engineers (Agricultural Engineering) of delta districts viz., Thanjavur, Tiruvarur, Nagapattinam and Pudukkottai to draw the amount as advance to procure fuel for the operation of Chain Saw Heavy Duty in GAJA Cyclone affected Delta districts, under Article 99 of the Tamil Nadu Financial Code Volume - I.

2) The Chief Engineer (Agricultural Engineering) has stated that the operation of Chain Saw Heavy Duty in GAJA Cyclone affected Delta districts has to be continued during this financial year 2019-20 and these machinery have to be used for cut and removal of fallen trees in GAJA Cyclone affected Delta districts. Since, the operation of Chain Saw Heavy Duty are continuing in different places, necessary arrangement have to be made for the supply of fuel (Petrol).The petrol has to be procured in advance and keep it ready for continuous operation with minimum down time.

3) Hence, as a special case, the Chief Engineer (Agricultural Engineering) has requested to permit the Assistant Executive Engineers of Agricultural Engineering Department in delta areas viz., Thanjavur, Pattukkottai, Mannargudi, Nagapattinam, Aranthangi and Pudukkottai to draw amount as advance to procure the fuel (Petrol) and 2T lubrication Oil for the operation of Chain Saw Heavy Duty in GAJA Cyclone affected areas.
