ORDER

In the G.O. first read above, orders were issued for sanction of a sum of Rs.100.00 lakhs for continuance of the scheme “Procurement and Distribution of Green Manure Seeds” during the year 2014 – 2015 with a target of 250 MTs. and directed to distribute the seeds to the farmers at 50% subsidy.

2) The Director of Agriculture in his letter second read above has stated that as raising a green manure crop and ploughing insitu at the time of flowering, is one of the recommended practices to increase the soil organic matter and improve the soil health, it is highly essential to continue the scheme further.

3) The Director of Agriculture has therefore sent the proposal for continuance of the above scheme during the year 2015 – 2016 at a financial outlay of Rs.145.00 lakhs with a target of 250 metric tones.

4) The Government, after careful examination, have decided to continue the above scheme during 2015-2016 and accord sanction for the continuance of the scheme of “Procurement and Distribution of Green Manure Seeds” during 2015-2016 at a financial outlay of

Rs.103.00 lakhs (Rupees One Hundred and Three lakhs only) with a target of 250 Metric Tones and also direct that the seeds be distributed to farmers at 50% subsidy.

5) The expenditure sanctioned in para 4 above shall be debited to the following head of account:-
