ORDER:-

In the Government Order 1st read above, a sum of Rs.2666.667 lakh as 1st instalment release of funds for implementation of "Rainfed Area Development" Component, under National Mission for Sustainable Agriculture 2018-19 was sanctioned which includes the Government of India share of Rs.1600.00 lakh and the State share of Rs.1066.667 lakh.

- 2. In the Government Order 2^{nd} read above, a sum of Rs.2666.67 lakh as 2^{nd} instalment release of funds was also sanctioned including the Government of India share of Rs.1600.00 lakh and the State share of Rs.1066.67 lakh.
- 3. Now, the Government of India in their letters 3rd read above, have released third instalment funds of Rs.350.00 lakh [(General Rs.276.15 lakh) + (SCSP Rs.70.00 lakh) + (TSP Rs.3.85 lakh)] towards Central share for the year 2018-19 for National Mission for Sustainable Agriculture in the funding pattern of 60:40 between the Central and the State Governments. By adding the corresponding 40% State share of Rs.233.333 lakh, the total allocation works out to Rs.583.333 lakh.

4. In the letter 5th read above, the Executive Director, Tamil Nadu Watershed Development Agency has forwarded the proposals received from the Director of Agriculture and the Director of Horticulture and Plantation Crops to the Government and requested to sanction a sum of Rs.583.333 lakh as 3rd Instalment for implementation of "Rainfed Area Development" Component, under National Mission for Sustainable Agriculture 2018 -19 and the Department wise split up details are as follows:-

9. Pending provision of such funds, the Director of Horticulture and Plantation Crops is authorized to draw a sum of Rs.209.836 lakh sanctioned in para 5 above and disburse the same to the Managing Director, Tamil Nadu Horticultural

Development Agency (TANHODA) for implementing the projects by relaxing quarterly control appropriation of funds. However, the expenditure shall be brought to the notice of the Legislature by Specific inclusion in the Supplementary Estimate 2019-20. The Director of Horticulture and Plantation Crops is directed to include this expenditure while sending the Budget proposal for Revised Estimate/Final Modified Appropriation 2019-20 and also to send necessary draft explanatory notes for including the above expenditure in the Supplementary Estimates 2019-20 to the Government in Finance (BG-1/Agri) Department at the appropriate time without fail.

- 10. The Director of Horticulture and Plantation Crops is the estimating, controlling and reconciling authority for the new Heads of Account opened in this order.
- 11. The Director of Horticulture and Plantation Crops is permitted to fix the Physical target based on the need and potential of the districts without exceeding the approved amount.
- 12. The department wise, physical and financial targets and head of account wise fund allocation for each department are mentioned in Annexure I and II of this order.
- 13. The implementing departments shall adhere to the physical and financial targets and head of account wise fund allocation as indicated in Annexure I and II.
- 14. The implementing departments should scrupulously follow the National Mission for Sustainable Agriculture guidelines issued by the Government of India and follow cost norms and approved pattern of assistance while implementing the projects and they should take due care to ensure that there is no duplication of subsidy. The implementing Departments should ensure proper implementation of the projects and complete them in time.
- 15. The implementing Departments should monitor the implementation process and progress at the State and District levels effectively and to furnish the monthly progress reports to the Nodal Agency and to the Government.
- 16. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10th of the subsequent month under intimation to the Government without fail.
- 17. This order issues with the concurrence of the Finance Department vide its U.O.No.19048/Fin(Agri)/2019, Dated: 24.5.2019 with Additional Sanction Ledger No.326 (Three hundred and twenty six).
