- 2. In the Government Order first read above, orders have been issued for sanctioning a sum of Rs.11061.51 lakh as Grant-in-Aid for the first quarter of 2022-23 to the Tamil Nadu Agricultural University, Coimbatore.
- 3. In the Government Order second read above, orders have been issued for sanctioning a sum of Rs.11061.51 lakh as Grant-in-Aid for the second quarter of 2022-23 to the Tamil Nadu Agricultural University, Coimbatore.
- 4. In the letter third read above, the Registrar, Tamil Nadu Agricultural University has requested the Government to sanction the Grant-in-Aid due for the third quarter of 2022-2023 to the tune of Rs.110,61,50,750/- out of Rs.442,46,03,000/- provided under State's Expenditure Head for utilizing the same for the following purposes:-

(Amount in Rupees) 63,22,35,750 Cost of Personnel for Third quarter 8,35,65,000 Travelling Allowance, Recurring expenditure for Third quarter Payment of Pension & Family 34,21,45,000 pension for Third quarter 4,62,05,000 25% State share on ICAR 20,00,000 5. Minor repair works 110,61,50,750 Total

- 5. He has further stated that an amount of Rs.43,50,03,000/- was deducted from the opening balance while calculating the Budget Estimate for the year 2022-2023 and hence the above amount may be additionally sanctioned to Tamil Nadu Agricultural University over and above the third quarter.
- 6. The Government have examined the request of the Registrar, Tamil Nadu Agricultural University and sanction a sum of **Rs.11061.5075 lakh** (Rupees One Hundred and Ten Crore Sixty One Lakh Fifty Thousand Seven Hundred and Fifty only) as Grants-in-Aid for the third quarter of 2022-2023 to the Tamil Nadu Agricultural University, Coimbatore.
- 7. The expenditure sanctioned in para 6 above shall be debited under the following head of account:-

- 8. The Joint Director of Agriculture, Coimbatore is authorized to draw the amount sanctioned in para 6 above and disburse the same to the Tamil Nadu Agricultural University, Coimbatore in relaxation of the quarterly restriction.
- 9. The accounts of the Tamil Nadu Agricultural University will be subject to audit by the Indian Audit and Accounts Department and for this purpose that Department shall have the right to access the books and accounts of the University.
- 10. The Registrar, Tamil Nadu Agricultural University is informed that in case of personnel retired from the Government service in the University, the general principle indicated in para 1 of G.O.(Ms).No.1625, Finance (Pension) Department, dated 22.12.1972 shall be followed.
- 11. The Registrar, Tamil Nadu Agricultural University is requested to ensure that the expenditure is kept within the grant sanctioned in para 6 above and does not exceed the limit under the Heads of Account indicated in paragraph 7 above.
- 12. This order issues with the concurrence of Finance Department vide-File No.22555/AU/2022 (Computer No.962669), dated 21.10.2022 (through e-office).
