ORDER:

In the Government Order first read above, administrative approval was accorded for the implementation of the Coconut Development Board assisted schemes during 2014-2015 at a cost of Rs.224.600 lakh, of which the share of the Coconut Development Board is Rs.164.800 lakh and share of the state Government is Rs.59.800 lakh. In the above order, among other things, administrative approval was accorded for implementation of the scheme "Integrated Farming in Coconut Holdings for Productivity Improvement — Laying out of Demonstration Plots (New & Maintenance)" in 600 ha, at a cost of Rs.105.00 lakh, which is 100% funded by Coconut Development Board.

- 2. Consequent on the release of Rs.61.25 lakh as first release by Coconut Development Board, orders have been issued in the Government Order second read above according financial sanction for a sum of Rs.61.25 lakh for implementation of the scheme "Integrated Farming in Coconut Holdings for Productivity Improvement Laying out of Demonstration Plots (New & maintenance)" for Maintenance of plots in 350 ha, during 2014-2015.
- 3. The Director of Agriculture in his proposal third read above has stated that, Coconut Development Board has now released a sum of Rs.43.75 lakh as second and final release for implementation of the scheme "Integrated Farming in Coconut Holdings for Productivity Improvement-Laying out of Demonstration Plots (New & maintenance)",

for laying of new plots in 250 ha during 2014-2015 and the same has been remitted into the Government account. He has furnished a copy of challan and requested to issue financial sanction for a sum of Rs.43.75 lakh as second and final instalment for implementation of the scheme "Integrated Farming in Coconut Holdings for Productivity Improvement-Laying out of Demonstration Plots (New and maintenance)" for laying of New plots in 250 Ha during 2014-2015. - 4. The Director of Agriculture has therefore, requested the Government to issue necessary financial sanction for a sum of Rs.43.75 lakh (Rupees Forty three lakh and seventy five thousand only) for implementation of the scheme "Integrated Farming in Coconut Holding for Productivity improvement-Laying out of Demonstration Plots(New & Maintenance) for laying of New plots in 250 Ha during 2014-2015.
- 5. The Government after careful consideration, accord financial sanction for a sum of Rs.43,75,000/- (Rupees Forty three lakh and seventy five thousand only) for implementation of the scheme "Integrated Farming in Coconut Holdings for Productivity Improvement-Laying out of Demonstration Plots (New & Maintenance)" for laying of New plots in 250 Ha during 2014-2015.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

2401 – 00 Crop Husbandry 114 – Development of Oilseeds III Centrally Sponsored schemes – SB – Integrated farming in Coconut holding for productivity improvement – 11 Subsides 01 – Individual Based subsidy.

7. The Director of Agriculture is authorized to incur the expenditure sanctioned in para 5 above.

- 8. The Director of Agriculture is directed to send detailed periodical reports to Government on the implementation of the schemes for information and review. He is also requested to utilize the entire amount within this financial year 2014-2015.
- 9. The progress reports in respect of the scheme indicating physical and financial achievements including the receipts accrued, if any, shall be furnished to Coconut Development Board regularly by the 10th of every month. In addition to the physical and financial progress reports, quantitative report on the outcome of the programme shall be sent to Coconut Development Board with reference to the objective of the programme.
- 10. The Director of Agriculture is also instructed to ensure that the utilization certificate and details of unspent balance, if any, are furnished to the Coconut Development Board / Government in time.
- 11. The operational guidelines and other directions issued by the Coconut Development Board shall be followed strictly while implementing the schemes.
- 12. The Director of Agriculture is also requested to give suitable directions to the District Joint Directors of Agriculture, Deputy Directors of Agriculture and Assistant Directors of Agriculture and field units to extend necessary assistance in implementing the programme benefiting the farming community.
- 13. The Director of Agriculture is also requested to ensure that the Physical and Financial target fixed for the project are to be achieved fully for the year 2014-2015 without fail.
- 14. This order issues with the concurrence of the Finance Department vide its U.O. No. 1492/Agriculture/2015, dated 13.01.2015.
