### **ORDER:-**

In G.O.1<sup>st</sup> read above the Government of Tamil Nadu announced the State Advised Price at Rs.2650/- per M.T. of Sugarcane for 2014-15 Sugar Season linked to an average recovery of 9.5% including Rs.100/- per M.T. towards transportation charges subject to a premium of Rs.23.20 per M.T. for every 0.1% increase in recovery above the average recovery of 9.5%.

2) In the reference 2<sup>nd</sup> read above, the Government of India have fixed the Fair and Remunerative Price (FRP) for sugarcane for 2015-16 season at Rs.2,300/- per M.T. linked to average recovery of 9.5% with an incentive of Rs.24.20 per M.T. for every increase of 0.1% recovery over and above 9.5% average recovery.

3) After careful consideration, the Government fix the State Advised Price for sugarcane for 2015-16 Sugar season at Rs.2,750/- per M.T. and Rs.100/- per M.T. towards transportation charges, totaling Rs.2,850/- per M.T. of sugarcane being supplied to sugar mills in Tamil Nadu linked to 9.5% average recovery with an incentive of Rs.24.20 per M.T. for every increase of 0.1% recovery over and above 9.5% average recovery.
