ORDER:

In the Government Order first read above, Government accorded administrative approval for implementation of Coconut Development Board assisted schemes in Tamil Nadu during 2015-16 at an outlay of Rs.187.500 lakh of which the share of Coconut Development Board, Kochi is Rs.137.500 lakh and share of the State Government is Rs 50.00 lakh. In the above order, among other things, administrative approval has been accorded for implementation of the scheme “Establishment of Regional Coconut Nurseries” at a cost of Rs.64.00 lakh which is to be shared by Coconut Development Board and the State Government on 50:50 basis (Coconut Development Board share Rs 32.00 lakh + State share Rs.32.00 lakh).

2. The Director of Agriculture in his letter third read above has stated that, the Coconut Development Board has released a sum of Rs.31.4275 lakh after deducting its share of the unspent balance of 2014-2015 and the amount released by the Coconut Development Board has been remitted into the Government account. The breakup details are as follows:-

3. The Director of Agriculture has therefore requested to the Government to accord financial sanction for a sum of Rs. 64.00 lakh for implementation of "Establishment of Regional Coconut Nurseries" during 2015-16.

4. The Government, after careful consideration accept the proposal of the Director of Agriculture and accord financial sanction for a sum of Rs. 64.00 lakh (Rupees sixty four lakh only) for implementation of the scheme "Establishment of Regional Coconut Nurseries" during 2015-2016.

5. The expenditure sanctioned in para-4 above shall be debited to the head of account indicated in the Annexure to this order.

6. The Director of Agriculture is authorized to draw and disburse the amount sanctioned in para 4 above.

7. The Director of Agriculture is instructed to send progress report periodically indicating physical and financial achievements to Government/Coconut Development Board without fail.

8. The Director of Agriculture is also instructed to ensure that the Utilization Certificate and details of unspent balance, if any, are furnished to the Coconut Development Board/Government in time.

9. The operational guidelines and other directions issued by Coconut Development Board shall be followed strictly while implementing the scheme.

10. This order issues with the concurrence of the Finance Department vide its U.O. No. 63243/Finance (Agriculture)/2015, dated 14.12.2015.
