#### ORDER:

In the Government Order 1<sup>st</sup> read above, the Government have accorded administrative sanction for a sum of Rs.48.80 lakh and financial sanction for a sum of Rs.24.40 lakh in the funding pattern of 60:40 ratio between Centre and State Government (i.e.GOI share Rs.14.64 lakh and State share Rs.9.76 lakh) for implementation of Crop Diversification Programme, a sub scheme under RKVY during 2017-18 and allocated Rs.18.40 lakh and Rs.6.00 lakh to the Director of Agriculture and the Director of Horticulture and Plantation Crops respectively.

- 2. Based on the 2<sup>nd</sup> installment allocation of Government of India, the Director of Agriculture and the Director of Horticulture and Plantation Crops have sent the proposal and requested the Government to provide financial sanction for the remaining 2<sup>nd</sup> installment release of funds to the tune of Rs.24.40 lakh towards implementation of the above project proposal under National Agriculture Development Programme 2017-18.
- 3. Further, the Executive Director, Tamil Nadu Watershed Development Agency has stated that the Director of Agriculture and the Director of Horticulture and Plantation Crops have proposed the following activities for a sum of Rs.17.40 lakh and Rs.7.00 lakh respectively:-

- 4. The Executive Director, Tamil Nadu Watershed Development Agency, has recommended the above project proposal.
- 5. The Government have examined the proposal of the Director of Agriculture, the Director of Horticulture and Plantation Crops and the Executive Director, Tamil Nadu Watershed Development Agency and accord financial sanction for a sum of Rs.24.40 lakh (Rupees Twenty four lakh and forty thousand only) in the funding pattern of 60:40 between the Centre and State Governments i.e. Government of India share Rs.14.64 lakh and State share Rs.9.76 lakh for implementation of Crop Diversification Programme, a sub scheme under Rashtriya Krishi Vikas Yojana during 2017-18 and allocate Rs.17.40 lakh and Rs.7.00 lakh to the Director of Agriculture and the Director of Horticulture and Plantation Crops respectively.
- 6. The expenditure sanctioned in para.5 above shall be debited to the Head of Account mentioned in the annexure to this order.
- 7. The Director of Agriculture is permitted to draw and disburse the amount of Rs.17.40 lakh sanctioned in para.5 above to the concerned.

The Director of Horticulture and Plantation Crops is authorized to draw the funds of Rs.7.00 lakh and disburse the same to the Managing Director, Tamil Nadu Horticulture Development Agency (TANHODA) in relaxation of quarterly restriction of funds for effective implementation of the scheme on time
