#### ORDER:

In the Government Order 1<sup>st</sup> read above, administrative approval was accorded for a sum of Rs.132.00 lakh over a period of three years viz. Rs.117.80 lakh for the year 2017-2018, Rs.8.00 lakh for the year 2018-2019 and Rs.7.00 lakh for the year 2019-2020 and financial sanction was also accorded for a sum of Rs.1,17,00,000/- for implementation of the project viz., Organic Inputs and Bio Inputs Characterization of Sustainable Organic Agriculture under Tamil Nadu Innovation Initiatives (TANII) Project for the year 2017-2018 (Round-I).

2. In the Government Order 2<sup>nd</sup> read above, financial sanction was accorded for a sum of Rs.8.00 lakh as second year release for implementation of the project viz., Organic Inputs and Bio Inputs Characterization for Sustainable Organic Agriculture under Tamil Nadu Innovation Initiatives (TANII) Project for the year 2018-2019.

- 3. In the Government Order 4<sup>th</sup> read above, necessary erratum was issued to para 4 of G.O.(D).No.204, Agriculture (AU) Department, dated 28.07.2017 viz. for the existing words "Rs.117.80 lakhs" the words "Rs.117.00 lakhs" shall be substituted.
- 4. In his letter 3<sup>rd</sup> read above, the Registrar, Tamil Nadu Agricultural University has stated that TANII Scheme on "Organic and Bioinputs Characterization for Sustainable Organic Agriculture" funded by the State Planning Commission is being operated at the Department of Sustainable Organic Agriculture, Tamil Nadu Agricultural University, Coimbatore with a budget outlay of Rs.132 lakhs for a period of three years (2017-2020). In this there is a provision for purchasing one Liquid Chromatography Mass Spectrometry (LCMS) at a cost of Rs.85.00 lakh. During the review meeting held at Tamil Nadu Agricultural University, it was decided to purchase equipments which are useful but not available elsewhere in Tamil Nadu Agricultural University. As two Liquid Chromatography Mass Spectrometry (LCMS) are available in the main campus, it is proposed to purchase the following equipments which will be useful for the ongoing research projects at the Department of Sustainable Organic Agriculture:-

Organic Inputs and Bio Inputs Characterization for Sustainable Organic Agriculture under
