Agriculture – Pradhan Mantri Fasal Bima Yojana (PMFBY) – Sanction a sum of Rs.306,61,43,114/- and to release a sum of Rs.299,49,96,618/- towards settlement of balance State share of Premium Subsidy to the Insurance Companies for Rabi 2019-2020, Kharif 2020 seasons and upfront subsidy for Rabi 2020-2021 season pertaining to Agriculture Crops– Accorded – Orders – Issued.

ORDER:-

According to the policy changes communicated by the Government of India for implementation of Revamped Pradhan Mantri Fasal Bima Yojana from Kharif 2020 onwards, in the Government Order first read above, among others, the Government have accorded administrative approval for the implementation of Revamped Pradhan Mantri Fasal Bima Yojana in all the districts of Tamil Nadu except Chennai from Kharif 2020 season as per the existing Government of India quidelines (revised).

- 2. In Government Order second read above, orders have been issued for implementation of the Revamped Pradhan Mantri Fasal Bima Yojana in all the Districts of Tamil Nadu except Chennai during Special and Rabi 2020-2021 by adopting new Co-Insurance Model on 80:20 proportionate sharing basis.
- 3. In Government Order third read above, orders have been issued for approval of the Cluster-wise Implementing Agencies selected by the Tender finalising Committee and also approved the district-wise, crop-wise Actuarial Premium Rates quoted by the selected Insurance Companies. The Government have permitted the Director of Agriculture to issue work orders to IFFCO-TOKIO for Clusters I, II and III and Agriculture Insurance Company of India Limited (AICIL) for Clusters IV, V and VI. The Government have also accorded administrative sanction for a sum of Rs.1470.7124 Crore (Agriculture: Rs.1436.328 Crore; Horticulture: Rs.34.3844 Crore) towards the settlement of state share of premium subsidy.

- 4. In continuation in the Government Order fourth read above, orders have been issued for notification of the Crops, Districts, Firkas, Revenue Villages, Insurance Units and Approved Premium Rates for Agricultural and Horticultural Crops for the effective implementation of Revamped Pradhan Mantri Fasal Bima Yojana (RPMFBY) during Rabi Season 2020-2021.
- 5. In accordance to Para 10 (iv) in Government Order 1st read above, the Director of Agriculture in his proceedings dated 31.10.2020 has already sanctioned a sum of Rs.124,16,32,417/- towards the State share of premium subsidy to the two Insurance Companies (AICIL Rs.74,29,05,310/-; OICL Rs.50,54,73,262/-) for Kharif 2019, Rabi 2018-19 (pending amount), Rabi 2019-2020 and Kharif 2020 (upfront) duly requesting the Agriculture Insurance Company of India Limited to adjust the sanctioned amount of Rs.124,16,32,417/- against the excess state share of premium subsidy available with Agriculture Insurance Company of India Limited of which the State share of Rs.74,29,05,310/- to Agriculture Insurance Company of India Limited. Out of the total sanctioned amount of Rs.50,54,73,292/- to Oriental Insurance Company Limited, the Director of Agriculture has also requested the Agriculture Insurance Company of India Limited to release a sum of Rs.48,16,14,443/- alone and the balance amount of Rs.2,38,58,819/- would be settled from the Budget allocation of 2020-2021.
- 6. The Director of Agriculture in his letter fifth read above has stated that the two selected Implementing Agencies viz., IFFCO-TOKIO General Insurance Company Ltd and the Agriculture Insurance Company of India Limited for implementation of Revamped Pradhan Mantri Fasal Bima Yojana during Special & Rabi Seasons, 2020-2021 have raised invoices for Rabi 2020-2021 season requesting the State share of advance premium subsidy (First Instalment) and the Oriental Insurance Company Limited has already raised invoices for balance amount of Rs.2,38,58,819/-. The details of amount requested by the Insurance Companies and the amount eligible for sanction to the Insurance Companies are as detailed below:-

- 7. The Director of Agriculture has requested the Government
- (i) to accord financial sanction for a sum of Rs.306,61,43,114/- of which
 - Rs.2,38,58,819/- to the Oriental Insurance Company Limited towards the balance State share premium subsidy for Rabi 2019-2020 & Kharif 2020 Seasons under Pradhan Mantri Fasal Bima Yojana.
 - Rs.202,18,82,169/- to the IFFCO-TOKIO and Rs.102,04,02,126/- to the AICIL towards the settlement of upfront State share of premium subsidy (First instalment) for Rabi 2020-2021 under Pradhan Mantri Fasal Bima Yojana.
- 8. The Government, after careful examination of the proposal of the Director of Agriculture, hereby accord sanction for a sum of Rs.306,61,43,114/- and to release a sum of Rs.299,49,96,618/- (Rupees Two Hundred and Ninety Nine Crore Fourty Nine Lakhs Ninety Six Thousand Six Hundred and Eighteen only) after adjusting the amount of Rs.7,11,46,496/- i.e. the excess State share of premium subsidy amount available with the Director of Agriculture remitted by the New India Assurance Company Limited (NIACL). The Director of Agriculture is directed to settle a sum of Rs.2,38,58,819/- to the Oriental Insurance Company Limited towards the balance State share premium subsidy for Rabi 2019-2020 & Kharif 2020 Seasons under Pradhan Mantri Fasal Bima Yojana, pertaining to Agriculture Crops, Rs.202,18,82,169/- to the IFFCO-TOKIO and Rs.102,04,02,126/- to the Agriculture Insurance Company of India Limited towards the settlement of upfront State share of premium subsidy (First instalment) for Rabi 2020-2021 under Pradhan Mantri Fasal Bima Yojana pertaining to Agriculture Crops.

- 10. Necessary additional funds of Rs.1696.91 lakh will be provided in Final Modified Appropriation 2020-2021. Pending provision of such funds, the Director of Agriculture is authorized to draw and disburse the amount sanctioned in para 8 above to the Agriculture Insurance Company of India Limited and Agriculture Insurance Company of India Limited will in turn transfer the respective premium subsidy to the Oriental Insurance Company Limited and IFFCO-TOKIO. However, the expenditure shall be brought to the notice of the Legislative by Specific Inclusion in the Supplementary Estimate 2020-2021. The Director of Agriculture is directed to include this expenditure while sending the Budget proposal for Final Modified Appropriation 2020-2021 and also to send necessary draft explanatory notes for including the above expenditure in the Supplementary Estimates 2020-2021 to Government in Finance (BG-1/Agriculture) Department at the appropriate time without fail.
