2. In the reference 7th cited, the Government of India have released a sum of Rs.77.38 crore as 2nd installment of Central Share under Normal Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme for the year 2015-16.

3. Earlier, the Commissioner of Fisheries has requested the Government to sanction an amount of Rs.210.00 lakh for the project "Fisheries Development in system tanks of Thiruvallur and Kancheepuram Districts" of the Department of Fisheries under National Agriculture Development Programme, already sanctioned in G.O.(Ms).No.60, Agriculture (AP1) Department, Dated:09.02.2016, pending provision of funds in the Final Modified Appropriation 2015-16 by assigning Additional Sanction Ledger No.

4. In view of the above, the Commissioner of Fisheries is authorized to incur expenditure for an amount of Rs.210.00 lakh (Rupees Two crore and ten lakh only) towards the implementation of the above project proposal of the Department of Fisheries.

- 6. Necessary additional funds of Rs.10.00 lakh will be provided in RBE / RE Final Modified Appropriation 2016-17. Pending provision of such funds in RBE / RE Final Modified Appropriation 2016-17 the Commissioner of Fisheries is authorized to draw and disburse the amount sanctioned in para 4 above to the concerned. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimate 2016-17. He is also requested to include this item of expenditure while sending proposals for RBE / RE Final Modified Appropriation 2016-17 and also to send necessary explanatory notes for including the above expenditure in the RBE/Supplementary Estimate 2016-17 to Government in Finance (AHD&F/BG-I) Department at the appropriate time without fail.
