In the Government Order 2<sup>nd</sup> cited, the Government have accorded sanction for a sum of Rs.2210.00 lakh for the project proposal "Formation of Agricultural machinery and implements Custom Hiring Centre" of the Department of Agricultural Engineering under National Agriculture Development Programme (NADP) for the year 2015-16.

- 2. In the reference 3<sup>rd</sup> cited, the Government of India have released a sum of Rs.77.38 crore as 2<sup>nd</sup> installment of Central Share under Normal Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme for the year 2015-16.
- 3. Earlier, the Chief Engineer (Agricultural Engineering) has requested the Government to sanction a sum of Rs.2210.00 lakh for the project "Formation of Agricultural machinery and implements Custom Hiring Centre" of Department of Agricultural Engineering under National Agriculture Development Programme 2015-16 already sanctioned in G.O (Ms).No.56, Agriculture (AP1) Department, Dated: 08.02.2016, pending provision of funds in the Final Modified Appropriation 2015-16 by assigning Additional Sanction Ledger No.
- 4. In view of the above, the Chief Engineer (Agricultural Engineering) is authorized to incur expenditure for an amount of Rs.2210.00 lakh (Rupees Twenty two crore and ten lakh only) over and above Budget Estimate 2015-16 provision towards the implementation of the above proposal of the Department of Agricultural Engineering.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

2402-00-Soil and Water Conservation-102-Soil Conservation Schemes in the Twelfth Five Year Plan- II State Plan JZ National Agriculture Development Programme (NADP-RKVY) – Agricultural Engineering Department.
