## ORDER:

During the 13<sup>th</sup> State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 05.06.2015 under the Chairmanship of Chief Secretary to Government to sanction the project proposals for the year 2015-16, the following proposal of Department of Milk Production and Dairy Development was approved under Supplementary Agenda with observations as mentioned in the minutes of the above meeting:-

2. In the letter 2<sup>nd</sup> read above, the Government of India have changed the sharing pattern from 50:50 to 60:40 between Centre & State with respect to RKVY scheme from 2015-16 onwards. Accordingly, the Government of India have finally allocated a sum of Rs.432.90 crore (Central Share Rs.259.74 crore: State Share Rs.173.16 crore).

- 3. Accordingly, the Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., has sent the proposal to the tune of Rs.810.00 lakh for the project "Strengthening of Refrigeration System, Processing and Storage facilities to develop market for product of rural milk producers in Chennai" to Government for issue of orders.
- 4. The Government after careful examination, accept the proposal of the Managing Director, Tamil Nadu Cooperative Milk Producers Federation Ltd., and accord sanction for a sum Rs.810.00 lakh (Rupees Eight crore and ten lakh only) for the project "Strengthening of Refrigeration System, Processing and Storage facilities to develop market for product of rural milk producers in Chennai" to the implementing Agency i.e. Department of Milk Production and Dairy Development / Tamil Nadu Cooperative Milk Producers Federation Ltd., under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana 2015-16, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Central and State Governments.
- 5. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Department of Milk Production and Dairy Development / Tamil Nadu Cooperative Milk Producers Federation Ltd., should take due care to ensure that there is no duplication of subsidy.
- 6. The Commissioner for Milk Production and Dairy Development should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the project.
- 7. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

2404 00 Dairy Development 102 Dairy Development Project - Schemes in the Twelfth Five Year Plan-II State Plan-JH-National Agriculture Development Programme (NADP-RKVY) - Milk Production and Dairy Development Department - 09. Grants-in-Aid - 03 - Grants for Specific Schemes.

8. Necessary additional funds of Rs.810.00 lakhs will be provided in Revised Estimate / Final Modified Appropriation 2015-16. Pending provision of such funds in Revised Estimate / Final Modified Appropriation 2015-16, the Commissioner for Milk Production and Dairy Development is authorized to draw and disburse the amount sanctioned in para 4 above. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimate 2015-16. He is also requested to include this item of expenditure while sending proposals for Revised Estimate / Final Modified Appropriation 2015-16 and draft explanatory notes for Supplementary Estimates 2015-16 to Government in Finance (AHD&F) Department without fail.

- 9. The Commissioner for Milk Production and Dairy Development shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the project.
- 10. The Commissioner for Milk Production and Dairy Development is directed to follow the respective guidelines while implementing the project.
- 11. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 12. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
- 13. This order issues with the concurrence of Finance Department vide its U.O. No.65299/AHD&F/2015, dated: 31.12.2015 and with Additional Sanction Ledger No.1807 (One Thousand Eight Hundred and Seven)
