ORDER:

In the Government Order first read above, orders have been issued according administrative approval for implementation of Pradhan Mantri Fasal Bima Yojana during 2018-2019 in Tamil Nadu at a cost of Rs.631.60 crore (Agriculture Department: Rs.621.15 Crore and Horticulture Department: Rs.10.45 Crore) in all the districts of Tamil Nadu (except Chennai). Further, the Director of Agriculture and Director of Horticulture and Plantation Crops have also been authorized to settle the pending premium subsidy claims of previous years raised by the Implementing Agencies based on the budget provision of 2018-2019.

2. In his letter second read above the Director of Agriculture has stated that the Government had authorised him to settle the pending premium subsidy claims of previous years raised by the Implementing Agencies based on the budget provision of 2018-19. But the Agriculture Insurance Company of India Limited, Chennai submitted the proposal only at the fag end of the year due to which the bills could not be submitted to treasury before the end of financial year 2018-19.

3. The Director of Agriculture has, therefore, requested the Government to accord Financial sanction for a sum Rs.18,68,703/- (Rs.18,49,426/- for settlement of claims to 545 farmers of Ramanathapuram district and Rs.19,277/- for the settlement of claims to 3 farmers of Tiruvarur district) towards the settlement of

State Government share of premium subsidy that had arisen due to wrong data entry made by the District Central Cooperative Bank, Ramanathapuram and District Central Cooperative Bank, Thanjavur covering 548 farmers of Ramanathapuram and Tiruvarur districts for Paddy II season, Rabi 2016-2017 under Pradhan Mantri Fasal Bima Yojana .

4. The Government, after careful examination of the proposal of the Director of Agriculture hereby accord financial sanction for a sum of Rs.18,68,703/- (Rupees Eighteen Lakh Sixty Eight Thousand Seven Hundred and Three only) towards the State Government share of premium subsidy that had arisen due to wrong data entry made by the District Central Cooperative Bank, Ramanathapuram and District Central Cooperative Bank, Thanjavur covering 548 farmers of Ramanathapuram and Tiruvarur districts for Paddy II season, Rabi 2016-2017 under Pradhan Mantri Fasal Bima Yojana .
