ORDER:

In the G.O. first read above among others, administrative approval has been accorded for the implementation of Pradhan Mantri Fasal Bima Yojana at a cost of Rs.487.3703 Crore in all districts of Tamil Nadu (except Chennai) from Kharif 2016 season onwards by replacing National Agricultural Insurance Scheme (NAIS).

- 2. In G.O. second read above, orders have been issued sanctioning a sum of Rs.193.882 Crore as 50% of State share of premium as upfront subsidy for Rabi 2016-17 under Pradhan Mantri Fasal Bima Yojana.
- 3. In his letter third read above, the Director of Agriculture has informed that the Government has issued financial sanction for Rs.193.882 Crore only and the balance amount as detailed below has to be released to the Insurance companies:-

- 4. Since the release of state share of premium subsidy is mandatory for settlement of compensation to the farmers by the insurance companies and sufficient budget provisions are available in the Revised Estimate 2016-17, he has requested the Government to accord financial sanction for the balance amount of Rs 11.646 crore. He has also stated that as per the operational guidelines of Pradhan Mantri Fasal Bima Yojana, the Government Premium subsidy to the selected Insurance Companies have to be routed through Agriculture Insurance Company (AIC) of India Limited strictly as per the guideline / orders of the Government and requested the Government to authorize him to draw and disburse the amount to Agriculture Insurance Company (AIC) of India Limited.
 - 5. The Government, after careful examination of the above proposal of the Director of Agriculture, hereby accord sanction for the balance amount of Rs.11.646 Crore (Rupees Eleven Crore Sixty Four Lakh and Sixty Thousand only) as 50% of State share premium as upfront subsidy for Rabi 2016-17 under Pradhan Mantri Fasal Bima Yojana.
 - 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

2401-00-Crop Husbandry 110 – Crop Insurance – State's Expenditure – JJ – Premium subsidy for implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) – State Share – 09 – Grants-in-Aid – 03 – Grants for specific schemes.

- 7. The Director of Agriculture is authorized to draw and disburse the amount sanctioned in para 5 above to the Agriculture Insurance Company of India Limited.
