ORDER:-

In the Government Order first read above, orders were issued according administrative sanction for implementation of the Scheme of “Special package to mitigate the losses incurred by Gaja Cyclone in Tamil Nadu during the year 2018-2019” for a sum of Rs.92.00 Crore in the Gaja affected districts as approved by Coconut Development Board. The Coconut Development Board have released a sum of Rs.80.00 Crore as part amount for the implementation of the said scheme. In Government order second read above, financial sanction orders for a sum of Rs.80.00 Crore have been issued and released Rs.56.8160 Crore under General Category and informed that the balance of Rs.23.184 crore shall be released in the ensuing Financial year .

In the letter third read above, the Director of Agriculture has now stated that the scheme could not be implemented during the year 2018-2019 as the release of funds were received at the end of the financial year. Since the scheme was not implemented in 2018-2019, the amount sanctioned was not drawn and the entire amount was surrendered.

3. The Director of Agriculture has further stated that in the letter fourth read above, the Coconut Development Board has issued Revalidation orders for implementation of the Special Package to mitigate the losses incurred by Gaja cyclone in Tamil Nadu for a sum of Rs.92.00 Crore which also includes the scheme of "Setting up of small coconut nurseries" for a sum of Rs.2.00 Crore. Hence the Director of Agriculture has requested to sanction a sum of Rs.2.00 Crore for implementation of the component "Setting up of small coconut nurseries" sanctioned under Special package to mitigate the losses incurred by Gaja cyclone in Tamil Nadu during 2019-2020.

4. The Government after careful examination, accept the proposal of Director of Agriculture and sanction a sum of Rs.2.00 Crore (Rupees two crore only) for implementation of the Coconut Development Board assisted Special package scheme – for "Setting up of Small Coconut Nurseries" during the year 2019-2020.

5. The amount sanctioned in para 4 above shall be debited under the following Head of Account:-
