Agriculture – PMKSY – Second instalment of funds for implementation of IWMP projects under Watershed Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Tamil Nadu for the year 2016-17 – Sanction and release a sum of Rs.41.633 Crore as Central and State matching share - Orders – Issued.

ORDER:

In the G.O. first read above, the Government have sanctioned and released a sum of Rs.62.300 Crore (Rupees Sixty two Crore and thirty lakh only) (GOI Share Rs.37.380 Crore and State Share of Rs.24.920 Crore) as first instalment towards Central and State Share for implementation of Integrated Watershed Management Programme (IWMP) projects under Watershed Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Tamil Nadu during the year 2016-17 in the funding pattern of 60:40.

2. In the reference second read above, the Government of India, Ministry of Rural Development, Department of Land Resources have sanctioned and released a sum of Rs.24.98 Crore (Rupees Twenty Four Crore and Ninety Eighty lakhs only) towards the release of 2nd installment of Central Share for implementation of Integrated Watershed Management Programme (IWMP) project under Watershed Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in Tamil Nadu during the year 2016-17 as follows:

3. In the reference 3rd read above, the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has stated that the activities are to be implemented as per the approved Annual Action Plan (AAP) of PMKSY. The funding pattern of the scheme is 60% Central share and 40% State share. Accordingly the Government of India have sanctioned and released the 2nd installment of Rs.2498.00 lakh (60%) and the Government of Tamil Nadu have to release Rs.1665.333 lakh (40%) as State share inline with the Central share as follows:-

The Chief Executive Officer, SLNA, TAWDEVA has also requested the Government to authorize the Director of Agriculture to draw the Central and State Share amount of Rs.4163.333 lakhs and to disburse the amount to the Chief Executive Officer, SLNA for depositing in the savings account opened for the purpose and further release to DWDA's of concern districts for implementation of IWMP Projects under Watershed Component of PMKSY for the year 2016-17 pending provision of funds in the FMA 2016-17.

5. Hence, the Chief Executive Officer, SLNA, TAWDEVA has requested the Government to sanction and release a sum of Rs.41.6333 Crore (Rupees Forty One Crore Sixty three lakh and thirty three thousand only) (Central Share of Rs.24.98 Crore and State Share of Rs.16.6533 Crore) towards the Central and State share for implementing IWMP projects in Tamil Nadu for the year 2016-17 pending provision of funds in the FMA 2016-17.

6. The Government after careful examination decided to accept the proposal of the Chief Executive Officer, SLNA, TAWDEVA and accord sanction a sum of Rs.41.6333 Crore (Rupees Forty One Crore Sixty three lakh and thirty three thousand only) as second instalment of funds towards the Central and State matching share for implementation of IWMP Projects under Watershed Component of PMKSY for the year 2016-17. As per the guidelines 1% of the amount sanctioned above shall be utilized for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.

7. The amount sanctioned in para 6 above shall be debited to the following head of account:-

2501 Special Programmes for Rural Development - 05 Wasteland Development - 101 National Wasteland Development Programme - Schemes shared between State and Centre - UB - Integrated Watershed Management Programme - 09 Grants - in - aid - 03 - Grants for specific schemes (DPC 2501-05-101-UB-0938).

8. The Director of Agriculture, Chennai is authorized to draw and disburse the said amount to the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency for depositing in the savings bank account maintained in Indian Overseas Bank, Guindy Branch opened for the purpose and further release to District Watershed Development Agencies of concerned districts for implementation of Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) as per the Guidelines of the Government of India. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency is authorized to utilize the amount earmarked for monitoring and evaluation of Integrated Watershed Management Programme (IWMP) Projects.

9. This order issues with the concurrence of Finance (Agriculture) Department vide its U.O. No. 20358/Agriculture/2017, dated 21.04.2017.


