ORDER:

In the Government Order 1st read above, sanction was accorded for a sum of Rs.50.00 Crore as first instalment for implementation of "Other Interventions" under Pradhan Mantri Krishi Sinchayee Yojana - Per Drop More Crop on 60:40 sharing basis between Government of India and State Government during the year 2017-2018. It was also ordered that as per the guidelines of Government of India, 1% of amount sanctioned above shall be utilised for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.

2. In the letters 2nd to 4th read above, the Government of India have sanctioned 2nd instalment of funds Rs.10200.00 Lakhs to Tamil Nadu under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) - Per Drop More Crop Other interventions as the Central share for activities of Water harvesting, Ground Water Development and Recharge, Renovation of existing water bodies and enhancing water conveyance efficiency in cluster approach and the Action Plan already approved which is part of the approved DIP/SIP and Annual Action Plan of PMKSY as follows:

3. In the letter 5th read above, the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has stated that the Government of India have informed that the activities are to be implemented by the State Level Nodal Agency(SLNA) for Integrated Watershed Management Programme (IWMP) in the State Government of Tamil Nadu. The funding pattern of the scheme is 60% Central share and 40% State share. In the 2nd State Level Sanctioning Committee meeting of PMKSY which was held on 20.4.2017, the Annual Action Plan of PMKSY 2017-18 was approved and the same was sent to Government of India for sanction of funds. The Government of India have sanctioned and released the 2nd instalment of 60% amount of Rs.10200.00 lakhs and the Government of Tamil Nadu have to release Rs.6800.00 lakhs as State Share in line with the Central share as detailed below:

Therefore, the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has requested the Government to sanction and release a sum of Rs.170.00 crores as 2nd instalment towards the Central share and State share for implementing the activities of water harvesting, ground water development and recharge, renovation of existing water bodies and enhancing water conveyance efficiency in cluster approach and the Action Plan already approved which is part of the approved DIP/SIP and Annual Action Plan of PMKSY – Per Drop More Crop other interventions in Tamil Nadu during the year 2017-18.

- 5. The Government after careful examination have decided to accept the proposal of the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency and accord sanction for a sum of Rs.170.00 crore (Rupees One hundred and seventy crore only) to implement "Other interventions" of PMKSY Per Drop More Crop for activities of water harvesting, ground water development and recharge, renovation of existing water bodies and enhancing water conveyance efficiency in cluster approach during the year 2017-18 on 60:40 sharing basis between Government of India and State Government. As per the guidelines, 1% of the amount sanctioned above shall be utilized for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.
- 6. The amount sanctioned in para 5 above shall be debited to the following Heads of Account:-

 - "2501 Special Programmes for Rural Development 05 Wasteland Development 796 Tribal Area Sub Plan Schemes Shared between State and Centre UA Integrated Watershed Management Programme 09 Grants in aid 03 Grants for Specific Schemes" (DP code 2501-05-796-UA-0939) Rs.1.70 Crore.
- 7. Necessary additional funds of Rs.151,59,33,000/- will be provided in Revised Estimate / Final Modified Appropriation 2017-2018. Pending provision of such funds, the Director of Agriculture is authorised to draw and disburse the amount sanctioned in para 5 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2017-2018. The Director of Agriculture is requested to include this expenditure while sending the proposal for RE / FMA 2017-2018 and also to send necessary draft explanatory notes for including the above expenditure in the Supplementary Estimates 2017-2018 to Government in Finance (Agriculture / BG-I) Department at the appropriate time without fail.
- 8. The Director of Agriculture is hereby authorized to draw and disburse the said amount to the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency for further release of funds to Project Officer/Joint Director of Agriculture of District Watershed Development Agencies of concerned districts for the implementation of Integrated Watershed Management Programme

projects as per the Common Guidelines of Government of India. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency is authorized to utilize the amount earmarked for monitoring & evaluation of Integrated Watershed Management Programme projects.
