ORDER:

In the Government Order first read above, orders have been issued according administrative approval for implementation of Pradhan Mantri Fasal Bima Yojana during the year 2018-2019 at a cost of Rs.631.60 crore (Agriculture Department: Rs.621.15 Crore and Horticulture Department: Rs.10.45 Crore) in all the districts of Tamil Nadu (except Chennai). Further, the Director of Agriculture and Director of Horticulture and Plantation Crops have also been authorized to settle the pending premium subsidy claims of previous years raised by the Implementing Agencies based on the budget provision of 2018-2019.

2. In his letter third read above, the Director of Agriculture has stated that based on the orders issued in the Government Order first read above he had requested the consent of the State Government to provide the State Share Premium Subsidy for a sum of Rs.25,68,466/- that had arisen due to belated submission of 34 declarations covering 254 farmers of Tiruvarur district for Paddy II Rabi, 2016-17 season under Pradhan Mantri Fasal Bima Yojana (PMFBY) to Agriculture Insurance Company of India Limited, Chennai by City Union Bank, Eravanacherry, Tiruvarur district. In the Government letter second read above, the Government had authorised the Director of Agriculture to settle the pending premium subsidy claims of previous years raised by the Implementing Agencies based on the budget provision 2018-2019. But, the Agriculture Insurance Company of India Limited,

Chennai had submitted the proposal only at the fag end of the year due to which the bills could not be submitted to Treasury during the year 2018-19.

3. The Director of Agriculture has, therefore, requested the Government to accord financial sanction for a sum of Rs.25,68,466/- towards the settlement of State Government share of premium subsidy that had arisen due to belated submission of 34 declarations covering 254 farmers of Tiruvarur district for Paddy II Rabi 2016-17 season, under Pradhan Mantri Fasal Bima Yojana (PMFBY) payable to Agriculture Insurance Company of India Limited, Chennai and to authorize him to draw and disburse the amount to Agriculture Insurance Company of India Limited.

4. The Government, after careful examination accept the proposal of the Director of Agriculture and hereby accord sanction for a sum of Rs.25,68,466/- (Rupees Twenty Five Lakh Sixty Eight Thousand Four Hundred and Sixty Six only) towards the State Government share of premium subsidy that had arisen due to belated submission of 34 declarations covering 254 farmers of Tiruvarur district for Paddy II Rabi 2016-17 season, under Pradhan Mantri Fasal Bima Yojana (PMFBY).

5. The expenditure sanctioned in para 4 above shall be debited under the following heads of account:-
