ORDER:

In the Government order 1st read above, the Government have released and sanctioned a sum of Rs.3870.00 Lakhs as Central Share on 50:50 basis for implementation of Water Conservation and Water Harvesting works under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) "Other Interventions" in Tamil Nadu during the year 2015-16 as per the Common Guidelines for watershed projects 2008 (Revised Edition 2011) of Government of India. Out of the above said amount, 1% amount has been earmarked for monitoring and 1% for evaluation of Integrated Watershed Management Programme (IWMP) Projects.

- 2. Subsequently, the Government of India have revised the funding pattern into that of 60:40 basis. Hence, in the Government order 3rd read above pending receipt of balance 10% Government of India share, the Government have sanctioned and released a sum of Rs.3096.00 Lakhs as State Government's share (40%) for implementation of Water Conservation and Water Harvesting works under PMKSY "Other Interventions" in Tamil Nadu during the year 2015-16 as per the Common Guidelines for watershed projects 2008 (Revised Edition 2011) of Government of India. Out of the above amount, 1% amount has been earmarked for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.
- 3. In the Government order 2nd read above, the Government have sanctioned a sum of Rs.83.33 crore (Government of India share Rs.75.00 crore and State Govt Share Rs.8.33 crores) on 50:50 sharing basis and subsequently in the Government order 4th read above, the Government have sanctioned a sum of Rs.51.6667 Crore being the balance State's share for implementation of IWMP in Tamil Nadu in revised pattern of assistance on 60:40 for the projects sanctioned during the year 2015-16 as per the Common Guidelines of Government of India. As per the guidelines, 1% of amount has been earmarked for monitoring and 1% for evaluation of IWMP Projects.

Agency, Tamil Nadu Watershed Development Agency has stated that the Government of India have not sanctioned and released a sum of Rs.774.00 Lakes being 10% balance towards remaining 1st installment of Central Share so far and it is construed that a sum of Rs.3870.00 Lakes towards the 1st installment of Central Share may be taken into account as 60% and requested that the State's Share may be revised and amended according to the Central Share as follows:-

- 5. Further, he has informed that the State Share of Rs.3096.00 Lakhs sanctioned already has been encashed and credited to the respective bank accounts. The excess drawal of Rs.516.00 Lakhs may be adjusted in the subsequent release of State Share as per the Government order fourth read above. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has requested the Government to issue necessary amendment order to the Government order third read above.
- 6. The Government after careful consideration decided to accept the proposal of the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency and accordingly in partial modification of the orders issued in Government order third read above, the Government permit the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency to implement the Integrated Watershed Management Programme Projects under Watershed Component of PMKSY during 2015-16 in the sharing pattern of 60:40 basis at a total cost of Rs.6450.00 lakhs and accord sanction for release of a sum of Rs.25.80 Crores being 40% State Share for implementation of Integrated Watershed Management Programme Projects in Tamil Nadu under Pradhan Mantri Krishi Sinchayee Jojana "Other Interventions" sanctioned during the year 2015-16 (vide G.O. first read above, a sum of Rs.38.70 Crores has already been sanctioned) As per the guidelines, 1% of the amount sanctioned shall be utilized for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.
- 7. Since the amount of Rs.30.96 Crores sanctioned in G.O. (Ms) No. 49, Agriculture (DPAP) Department, dated 05.02.2016 has already been drawn as per the revised sanction and thus a sum of Rs.5.16 Crores has been drawn in excess. Hence, the excess amount of Rs.5.16 Crores already drawn shall be diverted towards implementation of IWMP under PMKSY sanctioned vide Government order fourth read above.
- 8. This order issues with the concurrence of Finance (Agriculture) Department vide its U.O. No.21226/Agri/2016, dated 28.03.2016.
