ORDER:

In the Government Order first read above, among others, orders have been issued notifying the Crops, Districts, Firkas, Revenue Villages for Agricultural and Horticultural Crops for Kharif, 2019 Season under Pradhan Mantri Fasal Bima Yojana.

- 2. In the Government Order second read above, among others, orders were issued according administrative approval for implementation of Pradhan Mantri Fasal Bima Yojana in all the districts of Tamil Nadu except Chennai during 2019-2020 and 2020-2021 as per the existing Government of India guidelines and instructions issued thereon and also accorded financial sanction for an amount of Rs.634.7438 Crore (Agriculture: Rs.621.1542 Crore; Horticulture:Rs.13.5896 Crore) during the year 2019 2020 towards settlement of State share of premium subsidy, Payments for Professional and Special Services, advertisement and contingencies as provided in the Budget Estimate 2019-2020.
- 3. In the Government order third read above, orders have been issued sanctioning a sum of Rs.4,55,79,657/- towards settlement of upfront State Government share of premium subsidy for Kharif, 2019 Season pertaining to Horticulture Crops.
- 4. In his letter fourth read above, the Director of Horticulture and Plantation Crops has stated that in para 9 of the Government Order first read above, the Director of Horticulture and Plantation Crops has been authorized to draw and disburse the premium subsidy allotted for Directorate of Horticulture and Plantation

Crops in advance to Agriculture Insurance Company of India Limited and to the other approved Insurance Companies through Agriculture Insurance Company of India Limited as per the Government of India subsidy pattern in accordance to the claims submitted by the Implementing Agencies.

5. He has further stated that an amount of Rs.4,55,79,657/- has been settled to the concerned Insurance Companies towards the settlement of 1st instalment State Share premium subsidy for Kharif, 2019 Season. Now, Agriculture Insurance Company of India Limited and The Oriental Insurance Company Limited have raised their second instalment State Share premium subsidy for Horticulture Crops during Kharif, 2019-20 Season. The details of the second installment of State Share premium subsidy claimed by the Insurance Companies for Kharif, 2019-20 Season for Horticulture crops are as follows:-

- 6. The Director of Horticulture and Plantation Crops has, therefore, requested the Government to sanction a sum of Rs.1,96,35,774/- towards settlement to the two Insurance Companies as second instalment State share premium subsidy for Kharif, 2019-2020 Season for Horticulture crops of which Rs.1,17,27,364/- is payable to Agriculture Insurance Company of India Limited and Rs.79,08,410/- to The Oriental Insurance Company Limited and authorize him to draw and disburse the amount to the Agriculture Insurance Company of India Limited and Agriculture Insurance Company of India Limited will in turn transfer the respective premium subsidy to The Oriental Insurance Company Limited.
- 7. The Government, after careful examination of the proposal of the Director of Horticulture and Plantation Crops, hereby sanction a sum of Rs.1,96,35,774/-(Rupees One Crore Ninety Six Lakh Thirty Five Thousand Seven Hundred and Seventy Four only) towards the settlement of II instalment of State Share of premium

subsidy under Pradhan Mantri Fasal Bima Yojana for Kharif, 2019 season pertaining to Horticulture crops as detailed below:-

- (i). Rs.1,17,27,364/- (Rupees One Crore Seventeen Lakh Twenty Seven Thousand Three Hundred and Sixty Four only) to Agriculture Insurance Company of India Limited; and
- (ii). Rs.79,08,410/- (Rupees Seventy Nine Lakh Eight Thousand Four Hundred and Ten only) to The Oriental Insurance Company Limited.
- 8. The expenditure sanctioned in para 7 above shall be debited to the following heads of account:-
