ORDER:

In the G.O. first read above, administrative approval for the Sub-scheme project "Creation of facilities at Ambattur Dairy for Better product mix from the producer's milk received from the rural areas" at a total cost of Rs.1835.00 lakh, was given. Out of the project cost, Rs.1300.00 lakh shall be met under National Agriculture Development Programme and the remaining Rs.535.00 lakh from the Tamil Nadu Cooperative Milk Producers' Federation Limited (TNCMPF) funds. Accordingly, the Government released a sum of Rs.650.00 lakh out of the above mentioned sum of Rs.1300.00 lakh under National Agriculture Development Programme, 2013-14 as first instalment.
