ORDER:

In the Government order first read above, the Government have constituted State Level Sanctioning Committee (SLSC), Inter Departmental Working Group (IDWG) and District Level Implementation Committee (DLIC) for sanction of projects under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) and for monitoring at State and District Levels as per the guidelines for the scheme PMKSY.

- 2. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has now informed that the representations from various departments such as Department of Horticulture and Plantation Crops, Agricultural Engineering and Rural Development and Panchayat Raj were pointing out the inconsistency in the member list of State Level Sanctioning Committee (SLSC), Inter Departmental Working Group (IDWG) and District Level Implementation Committee (DLIC)
- 3. Hence, he has sent proposals to the Government with a request to issue necessary amendment orders to the Government order first read above.
- 4. The Government have examined the request of the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency and line Departments implementing Pradhan Mantri Krishi Sinchayee Yojana (PMKSY). After careful examination, the Government accept the proposal of the Chief Executive

Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency, Chief Engineer (AE), Director of Horticulture and Plantation Crops and Director of Rural Development and Panchayat Raj and in slight modification of the orders issued in Government order first read above, the Government issue changes in the State Level Sanctioning Committee (SLSC), District Level Implementation Committee (DLIC) and Inter Departmental Working Group (IDWG) already constituted in the Government order first read above as follows:-

- (a) In the State Level Sanctioning Committee (SLSC) constituted for Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) in the above Government order, the Director of Horticulture and Plantation Crops shall be included as a Member and the designation of Chief Executive Officer, Tamil Nadu Watershed Development Agency already included as Member shall be modified as Chief Executive Officer, State Level Nodal Agency/ Tamil Nadu Watershed Development Agency.
- (b) In the Inter Departmental Working Group(IDWG), constituted the designation of the Members already included shall be modified as follows:-

(c) In the District Level Implementation Committee (DLIC) under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) already constituted, the designation of the following Members shall be modified as follows:-

Existing	To be modified
Engineer in Chief (WRD)	Executive Engineer, WRD
Chief Engineer (Irrigation)	Executive Engineer, Agricultural Engineering Department

Since the post of Joint Director, Rural Development and Panchayat Raj and Project Director, District Rural Development Agency falls in the same category and the Deputy Director of Rural Development is not in existence, the Government direct that the above post included in the District Level Implementation Committee (DLIC) as Member shall be deleted.
