## ORDER;

In the Government Order 1<sup>st</sup> read above, orders were issued for sanction of Rs.48236.25 lakh as first installment (Government of India Share of Rs.17100.00 lakh and Matching State Share and Additional State Share Rs.31136.25 lakh (Rs.10830 lakh + Rs.20306.25 lakh)] towards smooth and successful implementation of Micro Irrigation Scheme under "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2017-2018. In the G.O. 2<sup>nd</sup> read above, orders

were issued revising the ratio of allotment between Small/Marginal farmers and Other farmers category from 60:40 to 80:20 and reduced the area of implementation so as to incur the expenditure within the allotted funds of Rs.48236.25 lakh. It was also ordered to utilize the savings amount of Rs.356.00 lakh of Government of India share arising due to area reduction and to include the same in the subsequent Government of India release.

- 2) In the G.O  $5^{th}$  read above the Government sanctioned a sum of Rs.5.70 crore being the 5% of State Share for administrative cost.
- 3) Further the Government of India have released a sum of Rs.4000.00 lakh to this State for Micro Irrigation as 2<sup>nd</sup> Installment & in the G.O sixth read above, the Government have sanctioned a sum of Rs.12326.13 lakh Government of India share Rs.4000.00 lakh and State Matching Share and Additional State's Share of Rs.8326.13 lakh as second instalment for implementation of Micro Irrigation under Per Drop More Crop of Pradhan Mantri Krishi Sinchayee Yojana for 2017-2018.
- 4) In the letter 3<sup>rd</sup> read above, the Government of India have released Rs.2655.35 lakh as 3<sup>rd</sup> instralment and the corresponding State Mandatory and Additional share for the total release of Government of India to be released is detailed below:

He has, therefore, requested the Government to release a sum of Rs.7738.06 lakh as  $3^{rd}$  installment for the smooth and successful implementation of Micro Irrigation Scheme during 2017-2018.

- 6) The Government after careful examination accept the proposal of Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release an amount of Rs.7738.06 lakh (Rupees seventy seven crore thirty eight lakh and six thousand only) which includes Government of India Share of Rs.2655.35 lakh and Matching State Share and Additional State Share of Rs.5082.71 lakh (Rs.1770.23 lakh + Rs.3312.48 lakh) being the 3<sup>rd</sup> installment towards the implementation of Micro Irrigation Scheme under Per Drop More Crop component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during the year 2017-2018. The above said expenditure will be met out within Budget Estimate 2018-2019.
