ORDER:

In the letter read above, the Director of Agriculture has stated that, earlier he had requested the Government of India to issue orders for considering yield data at higher level by Agriculture Insurance Company of India Limited for calculation of compensation claims for Navalpattu firka, Thiruverumbur block, Tiruchirapalli district which was additionally notified for Paddy II (Samba/ Thaladi/ Pishanam) under National Agricultural Insurance Scheme (NAIS) during Kharif 2008.

2. In this regard, Government of India in their letter dated 14.9.2010 had accorded permission to Agriculture Insurance Company of India Limited (AICIL) to work out and settle the admissible claims to farmers of Navalpattu firka of Thiruverumbur block, Tiruchirapalli district for Paddy - II crops (Rabi 2008-09) under National Agricultural Insurance Scheme on the basis of yield data available at next higher unit area as a special case. Based on the directions of Government of India, the Chief Regional Manager, Agriculture Insurance Company of India Limited. Chennai has requested consent for sanction of State share of Rs.6,18,895.29 being the compensation payable to 224 farmers of Navalpattu firka, Thiruverumbur block of Tiruchirapalli district. The above subject was placed in the 37th State Level Co-ordination Committee on Crop Insurance Meeting held on 18.11.2016 (Agenda No.14(3)) and the Committee have approved the proposal and permitted the Director of Agriculture to give concurrence to Agriculture Insurance Company of India Limited to release the State share due for compensation settlement. Accordingly, concurrence was accorded by the Director of Agriculture to the Chief Regional Manager, Agriculture Insurance Company of India Limited, Chennai for the above amount of Rs.6,18,895/- and was requested to obtain the Government of

India Share. In this regard, the Agriculture Insurance Company of India Limited has already informed that the Government of India share had been released by them and settled to farmers. The details of claims are given below:-

The Director of Agriculture has also informed that the State Government share of compensation claim amounting to Rs.6,18,895/- has not been paid previously and requested the Government to sanction a sum of Rs.6,18,895/- being the State Government share of compensation claim for Paddy II (Samba / Thaladi / Pishanam) season for the year 2008-2009 payable to 224 farmers of Navalpattu Firka, Thiruverumbur Block, Tiruchirapalli District and to authorize him to draw and disburse the amount to Agriculture Insurance Company of India Limited, Chennai.
- 4. The Government, after careful examination of the proposal of the Director of Agriculture, sanction a sum of Rs.6,18,895/- (Rupees Six Lakh Eighteen Thousand Eight Hundred and Ninety Five only) towards the State Government share of compensation claim payable to 224 farmers of Navalpattu Firka, Thiruverumbur Block, Tiruchirapalli District for Paddy-II (Samba / Thaladi / Pishanam) crop of 2008-2009 season under National Agricultural Insurance Scheme.
- 5. The amount sanctioned in para 4 above shall be debited to the following head of account:-

2401-00-Crop Husbandary-110 Crop Insurance – State's expenditure –JI-National Agricultural Insurance Scheme – 51 Compensation – 02 Other compensations (DPC 2401-00-110-JI-5124)

6. Necessary additional funds will be provided in Revised Estimate / Final Modified Appropriation 2017 – 2018 under the relevant head of accounts. Pending

provision of such funds, the Director of Agriculture is permitted to draw and disburse the amount sanctioned in para 4 above to Agriculture Insurance Company of India Limited. The Director of Agriculture is directed to include this expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2017–2018 to Government in Finance (Agriculture) Department at the appropriate time without fail.
