### ORDER :

The Government of India in their circular first read above have issued Guidelines for use of Aadhaar under section 7 of Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) (Central Act 18 of 2016) Act, 2016 as amended by the Aadhaar and Other Laws (Amendment Act, 2019) for the schemes funded out of Consolidated Fund of State.

2. Section 7 of the Central Act 18 of 2016 stipulates that as a condition for receipt of a subsidy, benefit or service for which the expenditure is incurred from the

Consolidated Fund of India or the Consolidated Fund of States, the Central Government or the State Government may require the individual to undergo Aadhaar authentication or to furnish proof of possession of Aadhaar number for the purpose of establishing identity of the said individual.

3. In this context, the Government of India have suggested that the State Governments issue section 7 notifications under their specific schemes which are funded out of Consolidated Fund of the State. Accordingly, the Head of Departments have sent their details of the Schemes for issue of notification under section 7 of Central Act 18 of 2016.

4. The Government after careful examination, as far the suggestion of Government of India, issue the Notification as appended to this order.

5. The approved Notifications I to VI under section 7 of the Aadhaar (Targeted Delivery of Financial and Other subsidies, Benefits and Services ) Act, 2016 as appended to this order is forwarded to the Works Manager, Government Central Press, Chennai-79 for publication in the Extraordinary in Tamil Nadu Government Gazettee.

6. The Works Manager, Central press is requested to publish the Notification in the next Extraordinary issue of the Tamil Nadu Government Gazettee and also requested to furnish 50 copies each of the Notification as published in the Tamil Nadu Government Gazettee to the Government in Agriculture & Farmers Welfare Department. The Works Manager, Government Central Press, Chennai-79 is also requested to quote the page number and date of Tamil Nadu Government Gazettee in which the Notifications are published.

7. Six copies of the Notifications are sent to the Tamil Development and Information (Translation) Department, Secretariat, Chennai-9. That Department shall also forward the Tamil translation immediately to the Director of Stationery and Printing, Chennai and to this Department.

8. The Director of Stationery and Printing and the Works Manager, Government Central Press, Chennai are requested to publish the translation in the District Gazette forthwith.

2. Any individual desirous of availing benefits under the schemes, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar, shall be required to make an application for Aadhaar enrolment before registering for the scheme provided that he is entitled to obtain Aadhaar as per section 3 of the said Act, and such individual shall visit any Aadhaar enrolment centre (list available at the Unique Identification Authority of India (UIDAI) website [www.uidai.gov.in](http://www.uidai.gov.in)) to get enrolled for Aadhaar.
3. As per regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the Department through its implementing agency, is required to offer Aadhaar enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar enrolment centre located in the respective Block or Taluka or Tahsil, the Department through its implementing agency shall provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves:

Provided that till the time Aadhaar is assigned to the individual, benefits under the schemes shall be given to such individual, subject to the production of the following documents, namely:-

- (a) if he/she has enrolled, his/her Aadhaar Enrolment Identification slip; and

(b) any one of the following documents, namely:-

- (i) Bank or Post office Passbook with photo; or
- (ii) Permanent Account Number (PAN) card; or
- (iii) Passport; or
- (iv) Ration Card; or
- (v) Voter Identity Card; or
- (vi) Mahatma Gandhi National Rural Employment Guarantee Act card; or
- (vii) Kisan photo passbook; or
- (viii) Driving Licence issued by the Licensing Authority under the Motor Vehicles Act, 1988 (Central Act 59 of 1988); or
- (ix) Certificate of Identity having photo of such person issued by a Gazetted Officer or a Tahsildar on an official letter head; or
- (x) Government Photo ID card or;
- (xi) PSU Photo ID Card:

Provided further that the above documents may be checked by an officer specifically designated by the Department for that purpose.

4. In order to provide benefits to the beneficiaries under the schemes conveniently, the Department through its implementing agency shall make all the required arrangements to ensure that wide publicity through the media shall be given to the beneficiaries to make them aware of the said requirement.
5. In all cases, where Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanism shall be adopted, namely:-
  - (a) in case of poor biometric authentication, Department through its implementing agency shall make provisions for finger print authentication for delivery of benefits in seamless manner;
  - (b) in case the biometric authentication through fingerprints is not successful, wherever feasible and admissible authentication by Aadhaar One Time Password or Time-based One Time Password with limited time validity, as the case may be, shall be offered; and
  - (c) in all other cases where biometric or Aadhaar One Time Password or Time-based authentication is not possible, benefits under the scheme may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response QR code printed on the Aadhaar Card in original and necessary arrangement

of Quick Response code reader shall be provided at the convenient locations by the Department through its implementing agency.

6. In addition to the above, in order to ensure that no bonafide beneficiary under the scheme is deprived of his due benefits, the Department through its implementing agency shall follow the exception handling mechanism as outlined in the Office Memorandum of DBT Mission, Cabinet Secretariat, Government of India dated the 19<sup>th</sup> December 2017.
7. This notification shall come into effect from the date of its publication in the Tamil Nadu Government Gazette.
