ORDER:

Sub Mission on Agricultural Mechanization (SMAM), a Centrally Sponsored Scheme, is being implemented in the State since 2014-15 as per

the guidelines of Government of India in the sharing pattern of 75:25. The Government of India have approved the Annual Action Plan for the year 2015-16 in the sharing pattern of 50:50 for Rs.1322.00 lakhs and allocated and released a sum of Rs.661.00 lakhs to this State for Sub Mission on Agricultural Mechanisation as per the revised funding pattern of 50:50. Subsequently, the Government of India has revised the sharing pattern as 60:40. Accordingly a sum of Rs.1101.67 lakhs (Government of India share 661.00 lakhs + State share 440.67 lakhs) was sanctioned vide G.O. second and fifth read above.

2. In the letter 3rd read above, the Government of India has approved Additional Annual Action Plan for Rs.2500.00 lakhs and sanctioned an amount of Rs.1500.00 Lakhs to Tamil Nadu as per the revised sharing pattern of 60:40 between Centre and State and released an amount of Rs.1002.90 Lakhs for General category and Rs.221.60 Lakhs for the special component plan for scheduled caste amounting to a total value of Rs.1224.50 Lakhs towards the implementation of Sub Mission on Agricultural Mechanization (SMAM) during the year 2015-16 for the Additional Annual Action Plan (AAP).

3. Accordingly, in the G.O 4th read above, an amount of Rs.2040.83 Lakhs (Government of India share Rs.1224.50 lakhs and State share Rs.816.50 lakhs) was sanctioned towards the implementation of Additional Annual Action Plan of Sub Mission on Agricultural Mechanization for the year 2015-16.

4. In the letter 6th read above, the Government of India have released additionally an amount of Rs.250.79 Lakhs for General category and Rs.2.45 Lakhs for the Tribal Sub Plan as per the revised sharing pattern of 60:40 between Centre and State, amounting to a total value of Rs.253.24 Lakhs towards the implementation of Sub Mission on Agricultural Mechanization (SMAM) during the year 2015-16 for the Additional Annual Action Plan (AAP). The corresponding State share is Rs.167.193 Lakhs for General category and Rs.1.633 Lakhs for the Tribal Sub Plan amounting to a total value of Rs.168.826 Lakhs. The Government of India have permitted the change of components for implementation of Additional Annual Action Plan of Sub Mission on Agricultural Mechanization 2015-2016, towards the total release of Rs.1477.74 lakhs.

5. In the letter 7th read above, the Chief Engineer (Agricultural Engineering) has submitted the proposal for balance release towards the Additional Annual Action Plan for the implementation of Sub Mission on Agricultural Mechanization for the year 2015-16, for the total amount of Rs.422.07 Lakhs, out of which Central share is Rs.253.24 Lakhs and State share is Rs.168.826 Lakhs as follows:-

Financial Assistance for procurement of Agricultural Machinery and Equipment

(i) To distribute 506 Nos. of Agricultural Machinery and Implements namely Powertiller (8 BHP and above), Tractors (8-15 PTO HP), Tractors (40-70 PTO HP) and Rotavators to farmers with the subsidy assistance during the year 2015-16 as per the Sub Mission on Agricultural Mechanization guidelines for an amount of Rs.422.07 Lakhs.

(ii) To allot an amount of Rs.417.99 Lakhs for General category farmers and Rs.4.0833 Lakhs for Tribal Sub Plan farmers for various components under Sub Mission on Agricultural Mechanization during 2015-16 for Additional Annual Action Plan as detailed below .

6. The Government after careful examination, have decided to accept the proposal of the Chief Engineer (Agricultural Engineering) and permit him to implement Sub Mission on Agricultural Mechanization as per the Additional Annual Action Plan for 2015-16 at a total outlay of Rs.422.07 lakhs and accord financial sanction for a sum of Rs.422.07 lakhs (Rupees Four Crores Twenty Two Lakhs and Seven Thousand only) (Government of India share Rs.253.24 Lakhs and State share Rs.168.826 lakhs) (Rs.417.99 lakhs for general category farmers and Rs.4.0833 lakhs for Tribal Sub Plan farmers towards the implementation of the scheme of Additional Annual Action Plan of "Sub Mission on Agricultural Mechanization" during the year 2015-16.

7. The expenditure sanctioned at para 6 above shall be debited under the following head of accounts as detailed below:-

For General category farmers – Rs.417.99 lakhs

"2401-00- Crop Husbandry-113. Agricultural Engineering - Schemes in the Twelfth Five year Plan – VI. Schemes shared between State and Centre-UB-Sub Mission on Agricultural Mechanization -11- Subsidies-01- Individual based subsidy (DPC:2401- 113-UB-1116)"

For Tribal sub plan farms -4.0833 lakhs

"2401-00-Crop Husbandry-796-Tribal Area Sub Plan – Schemes in the Twelfth Five Year Plan-VI. Schemes shared between State and Centre. UG-Sub Mission on Agricultural Mechanization -11- Subsidies- 01 – Individual based subsidy (DPC:2401-00-796-UG-1110)"

8. The Chief Engineer (Agricultural Engineering) is authorized to draw and disburse the amount sanctioned in para 6 above.

9. The chief Engineer (Agricultural Engineering) is authorized to utilize the savings amount if any towards the distribution of any of the Agricultural Machinery mentioned under the component "Financial Assistance for procurement of Agricultural Machinery and Equipment" within the respective Head of Accounts.

10. The Chief Engineer (Agricultural Engineering) is directed to send the monthly, quarterly and annual progress reports on the Physical and Financial achievement of the scheme regularly to Government.
