ORDER:

Sub Mission on Agricultural Mechanization (SMAM), a Centrally Sponsored Scheme, is being implemented in the State since 2014-2015 as per the guidelines of Government of India in the sharing pattern of 75:25. The Government of India has modified the sharing pattern from 75:25 into 60:40 from the year 2015-2016.

2. In the Government letter first read above, the Annual Action Plan of the Sub Mission on Agricultural Mechanization (SMAM) for the year 2017-18 for an amount of Rs.7760.14 lakh was forwarded to Government of India.

3. In the letter second read above the Government of India, have approved the component No.3, 4 and 6 of Sub Mission on Agricultural Mechanization (SMAM) guidelines for the Financial assistance for procurement of agricultural machinery and equipment, Establishment of Farm Machinery Banks for Custom Hiring, and Promotion of Farm machinery banks at village level respectively besides administrative expenses approval for an amount of Rs.7759.83 Lakh and sanctioned an amount of Rs.2328.04 Lakh to this State as per the sharing pattern of 60:40 between centre and state and released an amount of Rs.1763.88 Lakh for General category and Rs.564.16 Lakh for the special component plan for scheduled caste amounting to a total value of Rs.2328.04 Lakh as first installment towards the implementation of Sub Mission on Agricultural Mechanization (SMAM) during the year 2017-18 for the Annual Action Plan (AAP). 4. In the letter third read above, the Chief Engineer (Agricultural Engineering) has sent proposal for sanction of Rs.3880.07 lakh for the implementation of Sub Mission on Agricultural Mechanization for the year 2017-18 as first installment is as detailed below:-

(i) Financial Assistance for procurement of Agricultural Machinery and Equipment

It is proposed to distribute 909 Nos. of Agricultural Machinery and Implements namely Paddy Transplanter (4 rows), Paddy Transplanter (above 4 rows), Tractor (15-20 PTO HP), Tractor (20-40 PTO HP), Tractor (40-70 PTO HP), Tractor / Power tiller driven implements, Power tiller (8 BHP and above), Rotavator, Power weeder, Chaff cutter, Brush cutter and Multi Crop Thresher to farmers with the subsidy assistance during the year 2017-18 as per the Sub Mission on Agricultural Mechanization guidelines for an amount of Rs.633.24 Lakh, out of which Rs.443.40 Lakhs is for General category farmers and Rs.189.84 Lakh is for Special Component Plan farmers.

(ii) Establishment of Custom Hiring Centre (Farm Machinery Banks for Custom Hiring)

- (a) The main objectives of establishing Custom Hiring Centres are, 1) to provide hiring services for various agricultural machinery / implements applied for different farming operations, 2) to expand mechanized activities during cropping seasons in large areas especially in small and marginal holdings, 3) to introduce improved / newly developed agricultural implements and machinery in crop production.
- (b) Custom Hiring Centres (CHC) are basically a unit comprising a set of farm machinery, implements and equipment meant for custom hiring for the needy farmers. It is proposed to form 245 Custom Hiring Centres in the needy blocks of Tamil Nadu with a project cost of Rs.25.00 Lakh per Custom Hiring Centre (CHC). Out of Rs.25.00 Lakh, an amount of Rs.10.00 Lakh is Government assistance in the form of 40% subsidy and the remaining amount of Rs.15.00 Lakh is towards 60 % Entrepreneurs / Farmers / Group contribution. Total cost for the establishment of 245 Custom Hiring Centres is Rs.6125.00 Lakh, out of which the Government contribution is Rs.2450.00 Lakh (40% Government subsidy assistance) and the balance amount is Rs.3675.00 Lakh (60%), which is entrepreneurs'/ Farmers / Group contribution.

(c) The proposed Agricultural machinery and implements Custom Hiring Centres will be run by farmers or any one of the following farmers group viz., (1) Farm woman Empowerment group, (2) NABARD Farmers club, (3) Progressive farmers group, (4) Self Help Groups of farmers, (5) Entrepreneurs etc., These Custom Hiring Centers will be supported and monitored by the Agricultural Engineering Department (AED). The list of Agricultural Machinery and Implements required for each block will be based on cropping pattern and availability of existing Agricultural Machinery in the individual blocks.

(iii). Promotion of Farm machinery banks at village level

- The profitability of paddy cultivation and crops cultivation in dry land areas are very meager to the farming community and for which farmers prefer cash crops like Turmeric, Sugarcane, Plantation crops etc., One way of increasing the net income of the farmer is reducing the cost of cultivation. Agricultural Mechanization is an effective method to reduce the cost of cultivation considerably besides eliminating the drudgery of farm operations. Promotion of suitable machinery for dry land and wet land cultivation by establishing farm machinery banks is imperative in low farm power availability districts i.e., Ramanadhapuram, Thoothukudi, Sivaganga, Virudhunagar, Tiruvarur, Perambalur, Ariyalur, Karur, Krishnagiri. Thanjavur, Cuddalore, Erode, Tiruppur, Coimbatore, Pudukottai, Tirunelveli, Namakkal, Vellore, Dharmapuri, Villupuram, Tiruvannamalai and Dindigul where the farm power availability varies from 0.28 to 3.24 kW/Ha against the requirement of 4 kW/Ha.
- (b) The crop specific machinery available in farm machinery banks is of immense use to the farming community and is established by the Co-operative societies of farmers, Self Help Groups of farmer, Farmers Producers Organizations (FPOs) etc., The farmers groups should have a minimum of 8 members. The farm machinery bank possessed by the farmers groups use its machinery for hiring activity to the needy farmers in addition to their own use.
- (c) It is proposed to establish farm machinery banks (custom hiring centres) upto a project cost of Rs.10.00 Lakh each in 90 villages through farmers Groups / FPOs / any such entities on village basis, in low farm power availability districts as per Sub Mission on Agricultural Mechanization (SMAM) guidelines. Financial assistance of 80% of the project cost of Rs.8.00 Lakh will be provided to such farm machinery banks and for which the farmers groups should have minimum of 8 members. An amount of Rs.568.00 Lakh under General Category and Rs.152.00 Lakh under Special component plan for scheduled caste category amounting to a total amount of Rs.720.00 Lakh is required for establishing 90 village based farm machinery banks during the year 2017-18 under Sub-Mission on Agricultrual Mechanization (SMAM).

(iv). Administrative expenses

It is proposed to purchase Computers, Hand held Tablets, internet connectivity and other computer software and hard wares for developing State Agricultural Machinery Information Data Centre for an amount of Rs.76.83 Lakh, out of which the General Category allocation is Rs.58.40 Lakh and Special component plan category allocation is Rs.18.43 Lakh. The component wise budget requirement for General category and Special component plan category requirement for the first installment of Annual Action Plan of Sub Mission on Agricultural Mechanization for the year 2017-18 are as detailed below:-

- 5. The Government after careful examination, have decided to accept the proposal of the Chief Engineer (Agricultural Engineering) and permit him to implement Sub Mission on Agricultural Mechanization (SMAM) as per the approved Annual Action Plan of 2017-18 at a total outlay of Rs.7759.83 lakh and accord financial sanction for sum of Rs.3880.07 lakh (Rupees thirty eight crore eighty lakh and seven thousand only) (Government of India share is Rs.2328.04 lakh and State Share is Rs.1552.03 lakh) (Rs.2939.80 lakh for General Category farmers and Rs.940.27 lakh for Scheduled Caste Farmers) as first installment. The Chief Engineer (Agricultural Engineering) is also permitted to utilize the savings amount if any towards the distribution of any of agricultural machinery mentioned under the component "Financial Assistance for procurement of Agricultural Machinery and Equipment", under "Sub Mission on Agricultural Mechanization" during 2017-18 within the respective head of accounts.
- 6. The expenditure sanctioned at para-5 above shall be debited under the following head of accounts as detailed below:

namely Paddy Transplanter (4 rows), Paddy Transplanter (above 4 rows), Tractor (15-20 PTO HP), Tractor (20-40 PTO HP), Tractor (40-70 PTO HP), Tractor / Power tiller driven implements, Power tiller (8 BHP and above), Rotavator, Power weeder, Chaff cutter, Brush cutter and Multi Crop Thresher to farmers within the respective Head of Accounts.

- 9. The Chief Engineer (Agricultural Engineering), Agricultural Engineering Department is authorized to draw and disburse the amount under Administrative expenses component in advance towards the purchase of Computers, Hand held Tablets, internet connectivity and other computer software and hard wares for developing State Agricultural Machinery Information Data Centre for an amount of Rs.76.83 Lakh.
- 10. The Chief Engineer (Agricultural Engineering) is directed to send the monthly, quarterly and annual progress reports on the Physical and Financial achievement of the scheme regularly to Government.
