- 2. In the letter 2<sup>nd</sup> read above, The Government of India have made interim allocation of Rs.509.55 crore in the funding pattern of 60:40 under Normal National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana (Production Growth, Infrastructure and assets and Flexi fund streams) for the year 2016-17 (Central share– Rs.305.73 crore + State share Rs.203.82 crore). The Government of India have released its 1<sup>st</sup> installment Central share of Rs.152.87 crore.
- 3. Accordingly, the Commissioner of Fisheries has sent the project proposals along with details of compliance of the State Level Sanctioning Committee resolutions for the above projects to the tune of Rs.2833.815 lakh under National Agriculture Development Programme, 2016-17 to Government for issue of orders, except PP.No.14.70 which is being funded by NFDB.
- 4. The Government after careful examination, accept the following proposals of Commissioner of Fisheries and accord administrative sanction for a sum of Rs. 1518.44 lakh and release a sum of Rs.759.22 lakh (Rupees seven crore fifty nine lakh and twenty two thousand only) as 1<sup>st</sup> installment to the implementing Agency i.e. Department of Fisheries under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana 2016-17 towards implementation of the schemes detailed in the table below, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The final installment will be released after the receipt of Government of India 2<sup>nd</sup> and final installment. The funding pattern of the scheme is 60:40 sharing basis between the Centre and State Governments:-

- 5. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Commissioner of Fisheries should take due care to ensure that there is no duplication of subsidy.
- 6. The expenditure sanctioned in para 4 above shall be debited to the Head of Account and Component wise details are as mentioned in the Annexure to this order.
- 7. Necessary additional funds will be provided in RBE / Revised Estimate / Final Modified Appropriation 2016-17. Pending provision of such funds in RBE / Revised Estimate / Final Modified Appropriation 2016-17, the Commissioner of Fisheries is authorized to draw and disburse the amount sanctioned in para 4 above and deposit it in the P.D. account of the Commissioner of Fisheries. He is requested to include the above expenditure while sending proposals for RBE / Revised Estimate / Final Modified Appropriation 2016-17 to Government in

Finance (AH,D&F/BG-I) Department at an appropriate time. However, the above expenditure shall be brought to the notice of Legislative Assembly by a specific inclusion in the REB / Supplementary Estimate 2016-17. The Commissioner of Fisheries is also requested to send necessary draft explanatory notes to the Government in Finance (AHD&F) Department for the specific inclusion of the above expenditure in the RBE / Supplementary Estimates for the year 2016-17 at the appropriate time without fail.

- 8. The Commissioner of Fisheries should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.
- 9. The Commissioner of Fisheries shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the respective projects.
- 10. The Commissioner of Fisheries is directed to follow the respective operational guidelines while implementing the schemes.
- 11. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 12. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
- 13. This order issues with the concurrence of Finance Department vide its U.O.No.27699/AHD&F/2016, dated: 03.06.2016 with Additional Sanction Ledger No.312 (Three Hundred and Twelve).
