#### ORDER:

In the Government of India letter first read above, the administrative approval was accorded for an amount of Rs.1019.84 lakh (Central Share as Rs.611.90 lakh and State Share as Rs.407.94 lakh) by the Government of India under Pradhan

Mantri Krishi Sinchayee Yojana – Har Khet Ko Pani - Ground Water Irrigation to be implemented on community basis.

- 2. In the G.O. third read above, an amount of Rs.611.90 lakh (Rs.367.14 lakh as Central Share and Rs.244.76 lakh as State Share) was sanctioned based on the first instalment released by the Government of India during the year 2020-2021 vide Government of India letter second read above. The Chief Engineer (Agricultural Engineering) has reported that the works were completed (115 wells out of 166 wells) for an amount of Rs.610.28 lakh in 13 districts of Tamil Nadu viz., Ariyalur, Cuddalore, Krishnagiri, Kanyakumari, Chengalpattu, Madurai, Pudukottai, Ramanathapuram, Salem, Sivagangai, Tiruvallur, Virudhunagar and Villupuram districts.
- 3. In the Government letter fourth read above, the utilization certificate was sent to the Government of India for an amount of Rs.610.28 lakh. The balance amount of Rs.1.62 lakh was surrendered during the year 2020-2021. The surrendered amount of Rs.1.62 lakh is to be revalidated and included along with the second instalment amount for completing the entire target of the scheme.
- 4. In the Meanwhile, In the reference fifth read above, the revised administrative approval was accorded for an amount of Rs.912.78 lakh (Central Share as Rs.547.67 lakh and State Share as Rs.365.11 lakh) by the Government of India under Pradhan Mantri Krishi Sinchayee Yojana Har Khet Ko Pani Ground Water Irrigation.
- 5. In the Government of India letter sixth read above, Government of India have released an amount of Rs.160.85 lakh as the second instalment for the year 2021-2022 towards the grant under Pradhan Mantri Krishi Sinchayee Yojana Har Khet Ko Pani Ground Water Irrigation. The corresponding matching share of State Government for the central release is Rs.107.23 lakh which amounts to the sum of Rs.268.08 lakh as second instalment for the year 2021-2022. An amount of Rs.1.62 lakh is to be revalidated which is the unspent amount of the year 2020-2021. Hence the total amount of Rs.269.70 lakh has to be sanctioned for the year 2021-2022.
- 6. The revised administrative approval issued by Government of India is Rs.912.78 lakh. The total amount released so far is Rs.879.98 lakh (First instalment release: Rs.611.90 lakh + Second Instalment release: Rs.268.08 lakh). The balance amount of Rs 32.80 lakh is yet to be released (Central Share: Rs.19.68 lakh + State Share: Rs.13.12 lakh)
- 7. The project is proposed to be implemented in 8 districts viz., Cuddalore, Krishnagiri, Pudukottai, Ramanathapuram, Salem, Sivagangai, Tiruvallur and Kallakuruchi in safe firkas on cluster basis for the benefit of small and marginal farmers. The district wise allocation is also furnished by the Chief Engineer (Agricultural Engineering).
- 8. The following project components are proposed to be implemented as below,
  - Geo physical and Geological survey.
  - Construction of Bore well / Tube well.

- > Pumping System -Solar / Electric pumping system.
- ➤ Electric power supply up to the well from nearby substation in case of Electrical pumping system without electrical supply.
- Water Distribution Pipe.
- 9. Government of India have given procedure for release of funds under Centrally Sponsored Programmes (CSS), monitoring utilization of the funds released through Public Financial Management System (PFMS) with effect from July 2021.
- 10. Hence, the Chief Engineer (Agricultural Engineering) has requested the Government to Accord, the following:-
  - I. Revised Administrative Sanction for Rs.912.78 lakh
  - II. Sanction for an amount of Rs.268.08 lakh (Central Share Rs.160.85 lakh + State Share –Rs.107.23 lakh )
  - III. Revalidation for the balance unspent amount during the year 2020-21 of Rs.1.62 lakh (Central Share –Rs.0.97 lakh + State Share –Rs.0.65 lakh)
  - IV. Financial sanction for the total amount of Rs.269.70 lakh (Rs.268.08 lakh + Rs.1.62 lakh) is required for implementing the scheme of "Ground Water Irrigation" under Pradhan Mantri Krishi Sinchayee Yojana – Har Khet Ko Pani during the year 2021-22.
- 11. The Government after careful examination of the proposal of the Chief Engineer (Agricultural Engineering), hereby accord and issue orders on the following:-
  - I. Revised Administrative Sanction for an amount of Rs.912.78 lakh for the implementation of Scheme of "Ground Water Irrigation" under PMKSY Har Khet Ko Pani on community basis, during the year 2021-2022.
  - II. Sanction for an amount of Rs.268.08 lakh as second instalment release (Central Share – Rs.160.85 lakh + State Share – Rs.107.23 lakh)
  - III. Revalidate the balance unspent amount, during the year 2020-21 of Rs.1.62 lakh (Central Share –Rs.0.97 lakh + State Share Rs.0.65 lakh )
  - IV. Financial sanction for the total amount of Rs.269.70 lakh (Rs.268.08 lakh (Central share – Rs.160.85 lakh + State share – Rs.107.23 lakh) + Rs.1.62 lakh (Revalidation of unspent amount for the year 2020-2021)) as Second Instalment for implementing the scheme of "Ground Water Irrigation" on community basis, under Pradhan Mantri Krishi Sinchayee Yojana – Har Khet Ko Pani during the year 2021-2022.

12. The amount sanctioned in para 11 above shall be debited in the following Heads of Account:-

"2402-00-Soil and Water Conservation-102-Soil Conservation-Schemes Shared between State and Centre - UV Water to every farm (Har Khet Ko Pani) under the scheme of Ground Water Irrigation – PMKSY- 311 Subsidies - 01 Individual Based Subsidy" IFHRMS DPC 2402-00-102-UV - 31101) - Rs.161.82 lakh (Central Share)

"2402-00-Soil and Water Conservation-102-Soil Conservation-Schemes Shared between State and Centre - UZ Water to every farm (Har Khet Ko Pani) under the scheme of Ground Water Irrigation – PMKSY- State Share - 311 subsidies - 01 Individual Based Subsidy"

(IFHRMS DPC 2402-00-102-UZ - 31101) Rs.107.88 lakh (State Share)

- 13. The Chief Engineer (Agricultural Engineering) is permitted to draw and disburse the funds to the State Nodal Account (SNA) through Public Financial Management System (PFMS).
- 14. The Chief Engineer (Agricultural Engineering), Agricultural Engineering Department is permitted to adhere to the new procedure for release and utilization of funds of Centrally Sponsored Schemes (CSS) issued by Department of Expenditure, PFMS Division on the office memorandum No. 1(13) PFMS/FCD/2020, Dated: 23.03.2021. The Chief Engineer (Agricultural Engineering) is directed to follow the procedure given by Government of India for release of funds under Centrally Sponsored Schemes (CSS), monitoring utilization of the funds released through Public Financial Management System (PFMS) with effect from July 2021.
- 15. The Chief Engineer (Agricultural Engineering) is permitted to interchange the allocation and components within the proposed districts by addition or deletion of clusters based on the requirement at the fields without exceeding the overall cost norms. The Chief Engineer (Agricultural Engineering) is further directed to ensure that adequate allocation is given to SC / ST beneficiaries.
- 16. The Chief Engineer (Agricultural Engineering) is directed that the cost of the pumping units Solar shall be followed as per the MNRE cost norms under PM-KUSUM scheme at the time of execution and Electrical pumpsets shall be adopted based on the cost norms for the existing schemes implemented by the Agricultural Engineering Department at the time of execution.
- 17. The Chief Engineer (Agricultural Engineering) is requested to follow the guidelines while implementing this Scheme.
- 18. The Chief Engineer (Agricultural Engineering) is directed to send monthly, quarterly and annual progress reports on the Physical and Financial achievement of Scheme regularly to Government.

19. This order issues with the concurrence of the Finance Department vide its U.O. No. 54597/ Fin (Agri&FW)/2021, dated: 19.01.2022.
