#### ORDER:

During the Agriculture and Farmers Welfare Demand 2021-2022, the Hon'ble Minister for Agriculture and Farmers Welfare has made the following announcement on the Floor of the Assembly:-

- 2. Accordingly, the Vice Chancellor, Tamil Nadu Agricultural University has sent a proposal to the Government for "Upgrading the website of Tamil Nadu Agricultural University Agritech Portal to ensure speedy reach of Agriculture data to the farmers and release of video lessons on Agricultural Technology through social media" at a cost of Rs.40 lakh from the Tamil Nadu Agricultural University's Educational Research and Development Funds .

3. The Vice Chancellor, Tamil Nadu Agricultural University in his proposal has stated as follows:-

# Proposal No.I: Upgradation of Tamil Nadu Agricultural University Agritech Portal for effective Transfer of Technology at a cost of Rs.15 lakh:-

"Tamil Nadu Agricultural University Agritech Portal" was started during 2008-2009 and is operated and maintained by the Directorate of Extension Education, Tamil Nadu Agricultural University, Coimbatore. The portal contains A to Z exhaustive information on various aspects related to agriculture and allied sectors. The Portal contains around ten lakh standard pages both in English and Tamil with visual presentations benefiting Farmers, Extension functionaries, Researchers, Students, NGOs and General Public. However, the Portal poses certain difficulties like old format, monotonous layout, security vulnerabilities, and there is a need for content updation.

#### (a) The Justification / Rationale of the Project are as follows:-

- Tamil Nadu Agricultural University Agritech Portal needs to be completely upgraded since the present software has become obsolete, not amenable for updating and prone to hacking.
- The Portal will have a fresh look in terms of design, layout, software updated contents and more secure, that would meet the requirement of farmers, extension workers and others.

# (b) The Objectives are as follows:-

- (i) To Upgrade the Tamil Nadu Agricultural University Agritech Portal for better user experience.
- (ii) To update the technical contents in the portal based on the needs of Farmers, Scientists, Extension functionaries, Students, NGOs and General Public.
- (c) <u>Duration of the project is</u> 2021-2023.

# (d) The activities to be undertaken are as follows:-

- (i) Upgradation of the existing Agritech Portal using new software.
- (ii) To create a responsive template that will help in delivering the contents across all devices viz., Mobile phones, Tablets, iPad, Laptops, Desktops, etc.
- (iii) Transfer and editing of existing content to new portal and also adding new content.

#### (e) The Beneficiaries are as follows:-

Farmers, Extension functionaries, Students, Researchers, Other Institutions, NGOs, Media, and General Public.

- (iii) Increased awareness knowledge on agricultural technologies among portal users.

Proposal No II: "Strengthening of Educational Media Centre (EMC) for producing Video programmes for YouTube Channel" at a cost of Rs 25 jakk -

The Vice Chancellor, Tamil Nadu Agricultural University in his proposal has stated that Educational Media Centre (EMC) of Tamil Nadu Agricultural University (TNAU) is involved in production of video films and modules in agriculture and allied subjects with telecast quality for dissemination through Pothigai TV channel of Doordarshan Kendra, social media, web portals, etc. The Centre is also involved in production of agricultural video programmes for Government agencies, using the vast pool of Scientists available in Tamil Nadu Agricultural University and scientists of other institutes. Educational Media Centre (EMC) has recently started a YouTube channel for dissemination of agricultural technologies. This project envisages strengthening of Educational Media Centre (EMC) with professional video production equipment and software for producing high quality video programmes on latest agro-technologies for dissemination through YouTube Channel, due to its wide reach among farmers and others.

# (a) The Justification / Rationale of the Project are as follows:-

- (i) New professional video production equipment and software are essential for producing quality video programmes for YouTube.
- (ii) Since Tamil Nadu Agricultural University YouTube channel has good viewership with a growing subscriber base, the upgradation of Educational Media Centre (EMC) will be worthwhile.
- (iii) Necessary technical expertise is available in Tamil Nadu Agricultural University, which can be further effectively utilized for producing videos for YouTube.

#### (b) The Objectives are as follows:-

- (i) To equip Educational Media Centre (EMC) with professional video production equipment, software and upgrading Educational Media Centre (EMC) facilities.
- (ii) To produce high resolution videos on agro-technologies for dissemination through YouTube channel.
- (iii) To distribute the video programmes produced by Educational Media Centre (EMC) to extension functionaries, farmers, Krishi Vigyan Kendras (KVKs) and other agencies for large scale dissemination.
- (c) Duration of the project is 2021-2023.
- (d) The activities to be undertaken are as follows:-

# (i) Strengthening of Educational Media Centre (EMC) with professional video production equipment & Studio essentials

- (a) Purchase of professional video production equipment (camera and accessories) and editing workstations.
- (b) Annual Subscription of professional video and audio editing software packs and plug-ins.
- (c) Upgrading Educational Media Centre (EMC) with lighting, acoustics, digital screening and recording arrangements.

# (ii) Production and Dissemination of agro-technology videos

- (a) Production of high-quality video programmes on agro-technologies using professional video equipment and software.
- (b) Development of android mobile application for dissemination of YouTube videos.
- (c) Dissemination of video programmes through YouTube channel.

#### (e) <u>The Beneficiaries are as follows:-</u> Farmers, Extension functionaries, Students, Researchers, Other Institutions, NGOs, Media and General Public.
