During the 14th State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 19.02.2016 under the Chairmanship of Chief Secretary to Government to sanction the project proposals for the year 2016-17 among others, the following proposals of Tamil Nadu Agricultural University were approved with observations as mentioned in the minutes of the above meeting:-

- 2. In the letter 2nd read above, The Government of India have made interim allocation of Rs.509.55 crore in the funding pattern of 60:40 under Normal National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana (Production Growth, Infrastructure and assets and Flexi fund streams) for the year 2016-17 (Central share– Rs.305.73 crore + State share Rs.203.82 crore). The Government of India had released its 1st installment of Central share of Rs.152.87 crore.
- 3. Accordingly, the Director, Centre for Agricultural and Rural Development Studies (i/c), Tamil Nadu Agricultural University has sent the project proposals along with details of compliance to the State Level Sanctioning Committee resolutions for the above projects to the tune of Rs.1293.778 lakh under National Agriculture Development Programme, 2016-17 to Government for issue of orders.
- 4. The Government after careful examination accept the above proposals of Tamil Nadu Agricultural University and accord administrative sanction for a sum of Rs. 1293.778 lakh (Rupees Twelve crore ninety three lakh seventy seven thousand and eight hundred only) and also to accord financial sanction of Rs.646.889 lakh (Rupees six crore forty six lakhs and eighty eight thousand nine hundred only) for the following detailed proposals for the above purpose to the implementing Agency i.e. Tamil Nadu Agricultural University under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana 2016-17, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Centre and State Governments:-

- 5. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. The Registrar, Tamil Nadu Agricultural University should take due care to ensure that there is no duplication of subsidy.
- 6. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

2415-Agricultural Research and Education – 01-Crop Husbandry-120-Assistance to Other Institutions – Schemes in the Twelfth Five Year Plan – II State Plan- JD- Grants to Tamil Nadu Agricultural University – Schemes under National Agriculture Development Programme (NADP-RKVY) 09–Grants-in-Aid-03 Grants for Specific Schemes.

- 7. The Commissioner of Agriculture is authorized to draw and disburse the amount sanctioned in para 4 above to the concerned.
- 8. The Commissioner of Agriculture is authorized to draw an amount of Rs.10.6945 lakh and disburse it to the Tamil Nadu Agricultural University and the remaining amount of Rs.57.6945 lakh to the Director of Horticulture and Plantation Crops for implementing the project Promotion of organic cultivation for quality black pepper production from Kolli Hills of Tamil Nadu.
- 9. The Registrar, Tamil Nadu Agricultural University should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.
- 10. The Registrar, Tamil Nadu Agricultural University shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.

- 11. The Registrar, Tamil Nadu Agricultural University is directed to follow the respective operational guidelines while implementing the schemes.
- 12. The change of title name in respect of PP.No.14.38 shall be placed in the ensuing State Level Sanctioning Committee for ratification.
- 13. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.
- 14. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10th of the subsequent month under intimation to this Government without fail.
