ORDER:

In the Budget Speech of the year 2015-16 in the Tamil Nadu State Legislative Assembly, the Hon'ble Minister for Finance has made the following Announcement:-

2) Since funds are proposed to be provided under Warehouse Infrastructure Fund for the Project as per the above announcement, the Director of Agricultural Marketing and Agri Business has sent a proposal for

the appointment of NABCONS as consultant for the preparation of Detailed Project Report for the project of establishment of Integrated Cold Chain for Banana and Multi Commodities in Tamil Nadu in six regions in the format prescribed in Tamil Nadu Infrastructure Development Board Act and Rules 2012. In the G.O. second read above, the Government accorded permission to NABCONS to prepare the Detailed Project Report for establishing the Integrated Cold Chain and terminal market in Madurai, Tirunelveli, Coimbatore and Krishnagiri Cluster zones in Tamil Nadu at a cost of Rs.1.56 crores + service tax through Marketing Committee Fund under Tamil Nadu Transparency in Tenders Act 1998 and also to permit to issue notification under sec 16 (f).

3) After having detailed discussion with stake holders with their field study, the NABCONS have presented the final version of revised detailed project report for establishment of Supply Chain Management for Fruits and Perishables at a total cost of Rs.398.75 Crores and the Principal Secretary/ Commissioner of Agricultural Marketing and Agri Business has sent the Detailed Project Report for the approval. The above said Detailed Project Report had been forwarded to National Bank for Agriculture and Rural Development, through the NODAL Department (i.e) Finance (Res.II) Department.

4) In the letter fourth read above, the National Bank for Agriculture and Rural Development has given its final approval for the project outlay of Rs.39875.42 lakhs with Warehouse Infrastructure Fund loan of Rs.37881.65 lakhs for the construction of various infrastructures for supply chain management of Fruits, Vegetables and other Perishables in 10 Districts (Dharmapuri, Krishnagiri, Ramanathapuram, Thoothukudi, Tirunelveli, Tiruchirapalli, Dindigul, Theni, Coimbatore and The Nilgiris). The project is funded by way of term loan from National Bank for Agriculture and Rural Development under Warehouse Infrastructure Fund 2014-15 and no subsidy or grants is being extended to the project from National Bank for Agriculture and Rural Development.

5) The Principal Secretary/Commissioner of Agricultural Marketing and Agri Business has now requested the Government to issue Administrative Sanction for the construction of various infrastructure for supply chain management of Fruits, Vegetables and other Perishables in 10 Districts with a total Financial Outlay of Rs.39875.42 lakhs by way of term loan under Warehouse Infrastructure Fund (Rs.37881.65 lakhs + State Government contribution of Rs.1993.77 lakhs).

6) The Government, after careful consideration of the proposal of the Principal Secretary / Commissioner of Agricultural Marketing and Agri Business, accord administrative sanction for the construction of various infrastructure for supply chain management of Fruits, Vegetables and other Perishables in 10 Districts with a total Financial Outlay of Rs.39875.42 lakhs (Rupees Three Hundred and Ninety Eight Crores Seventy Five Lakhs and Forty Two Thousand only) with Warehouse Infrastructure Fund loan of Rs.37881.65 lakhs (Rupees Three Hundred and Seventy Eight Crores Eighty one lakhs and Sixty Five thousand only) and Rs.1993.77 lakhs (Rupees Nineteen Crores Ninety Three Lakhs and Seventy Seven Thousand Only) from State Government funds. The detailed order will be issued separately.

7) This order issues with the concurrence of Finance Department vide its U.O. No.35332/Agri/2016, dated 21.06.2016.
