### ORDER:

The Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) is a Centrally Sponsored Scheme on 50:50 basis (Government of India 50% State Share 50%) formulated by Ministry of Agriculture and Farmers Welfare, Government of India with a vision to ensure access to some means of protective irrigation to all agricultural farms in the country to produce “per drop more crop” to substantially increase irrigation in the rainfed areas and thereby increase agricultural productivity manifold from 2015-16. Under the PMKSY, Watershed Management is one of the components and under this, Converging with Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for creation of water source to full potential in identified backward rainfed blocks including renovation of traditional water bodies is included.

2. In the letter 1<sup>st</sup> read above, the Government of India have released a sum of Rs.1150.00 lakhs in 60:40 sharing pattern for the year 2015-16 for implementation of works for supplementing material cost of Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) works on water conservation & ground water recharge in most vulnerable blocks notified by Central Ground Water Board

3. In the letter second read above, the Government of India has informed that the funding pattern of PMKSY is changed into 60:40.

4. Therefore, the Director of Rural Development and Panchayat Raj has requested the Government in Rural Development and Panchayat Raj Department to sanction a sum of Rs.19,16,00,000/- (Central Share Rs.1150.00 Lakhs and Rs.766.00 Lakhs as State assistance) for the year 2015-16 under PMKSY for implementation of Government of India under MGNREGA and to permit him to draw and transfer the amount to the District Rural Development Agency and to transfer the same to Tamil Nadu Employment Guarantee Fund by providing necessary funds in the FMA for 2015-16 under the relevant head in Agriculture Department.

5. The Government after careful consideration, decided to accept the proposal of the Director of Rural Development and Panchayat Raj and to accord sanction of funds for supplementing material cost of MGNREGA works on water conservation & ground water recharge in most vulnerable blocks notified by Central Ground Water Board (CGWB) under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY): Other Interventions as per the guidelines during the year 2015-16 in the sharing pattern of 60:40 basis at a total cost of Rs.1916.00 lakhs and release a sum of Rs.1916.00 lakhs (Rupees Nineteen Crores and Sixteen lakhs only) (Government of India Share Rs.1150.00 Lakhs and State Government share Rs.766.00 lakhs ) for implementation of MGNREGS in Tamil Nadu under Pradhan Mantri Krishi Sinchayee Yojana.

6. The amount sanctioned in para 5 above shall be debited to the following Heads of Account:-
