### ORDER:

During the 14<sup>th</sup> State Level Sanctioning Committee meeting of National Agriculture Development Programme held on 19.02.2016 under the Chairmanship of Chief Secretary to Government to sanction the project proposals for the year 2016-17 among others, the following proposals of Department of Seed Certification & Organic Certification were approved with observations as mentioned in the minutes of the above meeting:-

2. The Government of India have made interim allocation of Rs.509.55 crore in the funding pattern of 60:40 under Normal National Agriculture Development Programme / Rashtriya Krishi Vikas Yojana (Production Growth, Infrastructure and assets and Flexi fund streams) for the year 2016-17 (Central share –Rs.305.73 crore + State share –Rs.203.82 crore). The Government of India had released its 1<sup>st</sup> installment of Central share of Rs.152.87 crore.

3. Accordingly, the Director of Seed Certification & Organic Certification has sent the project proposals along with details of compliance of the State Level Sanctioning Committee resolutions for the above projects to the tune of Rs.155.425 lakh under National Agriculture Development Programme, 2016-17 to Government for issue of orders.

4. The Government after careful examination, accept the proposals of Department of Seed Certification & Organic Certification and accord administrative sanction for a sum of Rs.155.425 lakh and also to accord financial sanction for Rs.77.712 lakh (Rupees Seventy seven lakhs seventy one thousand and two hundred only) for the above purpose to the implementing Agency i.e. Department of Seed Certification & Organic Certification under National Agriculture Development programme / Rashtriya Krishi Vikas Yojana 2016-17, subject to the condition that under no circumstances any deviation from the decision of the State Level Sanctioning Committee is permitted. The funding pattern of the scheme is 60:40 sharing basis between the Centre and State Governments.

5. The funds available under existing Centrally Sponsored / Central Sector Schemes should invariably be tapped before using Rashtriya Krishi Vikas Yojana / National Agriculture Development Programme funds for the above projects. The projects should follow centrally prescribed cost norms and approved pattern of assistance. Department of Seed Certification & Organic Certification should take due care to ensure that there is no duplication of subsidy.

6. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

- (i) 2435 Other Agricultural Programmes – 01 Marketing and Quality Control – 102 Grading and Quality Control facilities – Schemes in the Twelfth Five Year Plan- II State Plan – JK National Agriculture Development Programme (NADP-RKVY) – Directorate of Seed Certification. (Rs.31.397 lakh)

The Concerned Pay and Accounts Officer / Treasury officers are requested to make necessary adjustments entries at the end of the financial year 2016-17.

7. Necessary additional funds will be provided in RBE / Revised Estimate / Final Modified Appropriation 2016-17 under the relevant head of accounts. Pending provision of such funds the Director of Seed Certification & Organic Certification is permitted to draw and disburse the amount sanctioned in para 4 above to the concerned. However, the expenditure shall be brought to the notice of Legislature by a specific inclusion in the RBE / Supplementary Estimate. He is also requested to include this expenditure while sending the proposal for RBE / Revised Estimate / Final Modified Appropriation 2016-17 and also to send necessary explanatory notes for including the above expenditure in the RBE / Supplementary Estimate 2016-17 to Government in Finance (Agri/BG.I) Department at the appropriate time without fail.

8. The Director of Seed Certification & Organic Certification is authorized to draw and disburse the amount sanctioned in para 4 above to the concerned.

9. The Director of Seed Certification & Organic Certification should personally oversee and ensure the technical, quality control and reasonableness of rates and estimates of the implementation of the schemes.

10. The Director of Seed Certification & Organic Certification shall observe the comments / suggestions of State Level Sanctioning Committee while implementing the projects.

11. The Director of Seed Certification & Organic Certification is directed to follow the respective operational guidelines while implementing the schemes.

12. The Tamil Nadu Watershed Development Agency which is the Nodal Agency, in consultation with the Head of Departments' to prescribe benchmarks for outcomes, milestones with time lines and monitor the outcomes through RDMIS to ensure that they are adhered to by the implementing departments.

13. The Executive Director, Tamil Nadu Watershed Development Agency is requested to send the monthly progress report to the Government of India, in the prescribed format by 10<sup>th</sup> of the subsequent month under intimation to this Government without fail.
